- Norm will brief the workgroup on ongoing CBP BMP verification efforts, workgroup membership and highlights from the Bay-wide stormwater retreat held in May

- On May 29, the Watershed Technical Committee (WTC), conditionally approved the BMP recommendations for retrofits and state performance standards. The four changes include a new curve for nitrogen to reflect nitrate leaching from pervious area, a revised method to report redevelopment credits, and a short and long term strategy to incorporate rates into CAST, and an additional qualifying condition for BMP restoration credits. A summary of the proposed changes is attached, and has gotten feedback from the respective expert panels. The USWG is asked to review and endorse the proposed changes, and forward revised memos to the Water Quality Goal Implementation Team.

- EPA provides CBP partners with nearly 20 million dollars of funds through the Chesapeake Bay Implementation Grants (CBIG) and Chesapeake Regulatory and Accountability Program Grants (CBRAP). EPA is requesting feedback from the Partnership on recommended priority practices for stormwater to include in the 2013 grant guidance to strengthen the focus between these grant opportunities and the final Phase II WIPs developed by the states/DC.
