CBSAC Advisory Report

- Lynn Fegley (MD DNR) presented the latest draft of the 2012 CBSAC Blue Crab Advisory Report.
- The Executive Committee agreed to endorse the report with a few modifications.
- Outcome: CBSAC agreed to make these changes and will redistribute a revised copy to the Executive Committee on Wednesday (7/18) for final endorsement.

New Chesapeake Bay Program Shad Indicator

- The Executive Committee was presented with several options for revision of the current CBP shad indicator as described in the above referenced handout. Discussion focused on whether or not we need a shad indicator at all or how best to devise a new indicator. Due to shad management being considered restoration and not a fishery since the species has been under a moratorium, ideas included creating a whole habitat indicator that would consider habitat range, available stream miles, and any available population estimates. This would require working with other GITs, STAR, and ASMFCs American Shad Technical Committee in order to develop a new indicator.
- Outcome: Executive Committee agreed to look into development of a new CBP indicator for American Shad.

June Full GIT Meeting Summary

- The Executive Committee discussed what to do with the short- and long-term action items identified by the full GIT.
- Outcome: GIT staff was tasked with reviewing the action items, categorizing them into relevant groups, and developing an initial prioritized list for further review by the Executive Committee.

December Full GIT Meeting Planning

- The Executive Committee discussed ideas concerning hosting the December full GIT meeting at Port Isabel on Tangier Island from December 6th-8th. Holding the meeting on Tangier Island would allow the GIT to reach out to key waterman and stakeholders in the area, but may cause some difficulty in getting people to and from the meeting. We will need to target our membership and ensure participation from those willing to contribute.
- Outcome: The Executive Committee agreed to target Port Isabel for the December full GIT meeting and staff was tasked with providing analysis of current GIT membership and participation.

The EC was briefed on the oyster metrics and blueprint put together for Harris Creek, the high level of blue crab 2012 recruitment, and invasive catfish shocked some of the EC members as they had no previous knowledge of their presence within the Chesapeake Bay.
