EPA provides CBP partners with nearly 20 million dollars of funds through the Chesapeake Bay Implementation Grants (CBIG) and Chesapeake Regulatory and Accountability Program Grants (CBRAP). EPA is requesting feedback from the states and partnership on proposed 2012 grant guidance to target and prioritize stormwater practices and integrate them with the final phase 2 WIPS developed by the states.
