- RAFT is an innovative “collective impact” collaborative approach to climate resilience that leverages the expertise and resources of multidisciplinary partners and diverse stakeholders to assist coastal localities striving to increase their resilience, which developed by VIMS, ODU, and UVA. It consists of three stages: a Scorecard assessing a community’s resilience; a community workshop to go over the Scorecard results and help them develop a Resilience Action Checklist of actions to pursue over a year’s time to become more resilience; and the one-year Implementation stage. - The Modeling Workgroup will be completing the 2019 assessment of climate change effects on the Phase III planning targets in November of this year. It is anticipated that the Modeling Workgroup will approve the methods of addressing selected topics at the July 16th and 17th Quarterly Review with the remainder of the topics approved at the October meeting. Any modifications necessary for approval will be made in October and November so that by early December the partnership will have modeling methods and simulations ready for the 2020 year of partnership review.
