The Agreement is the culmination of two years' effort by the Chesapeake Bay Program partners to create a collaborative plan for the next generation of restoration, conservation and stewardship of the Bay, its tributaries and the tens of thousands of acres of lands that surround them. The Chesapeake Bay Program is a regional partnership that has coordinated and conducted the restoration of the Chesapeake Bay for 30 years, since its formation thirty years ago in 1983. Partners include the U.S. Environmental Protection Agency, representing the federal government; the U.S. Department of Agriculture; the states of Delaware, Maryland, New York, Pennsylvania, Virginia and West Virginia; the District of Columbia; the Chesapeake Bay Commission, a tri-state legislative body; and advisory groups of citizens, scientists and local government officials.
