During the WTWG May 29th, 2012 Conference call Norm and Tom presented on the Expert Panel Recommendations on Stormwater Retrofits, which were approved by the Urban Stormwater Workgroup and conditionally accepted by the WTWG. The USWG revised these reports based on WTWG's comments. Norm and Tom will lead the discussion revisiting the stormwater BMP recommendations for retrofits and performance.

Decision Requested: WTWG approval to bring these recommendations forward to the Water Quality Goal Implementation Team for final approval and incorporation into the Chesapeake Bay Program models.
