CRP Benefits

Since 1985, CRP has:

- Established 10s of millions of acres of wildlife habitat
- Prevented more than 9 billion tons of soil from eroding
- Reduced N and P runoff relative to annually tilled cropland by 95 and 85 percent, respectively
- Sequestered an annual avg of 49 million tons of GHGs
- Created/restored nearly 2.7 million acres of wetlands
- Buffered more than 170,000 stream miles, enough to go around the world 7 times



CRP Enrollment Status

24 million acre CRP enrollment cap

- Applies to all CRP signup types, including CREP

As of December 2016

- Total acres accepted: 23.5 million
 - General: 16.16 million acres
 - Continuous (non-CREP): 5.87 million acres
 - Farmable Wetland: 0.40 million acres
 - CREP: 1.06 million acres
 - Grasslands: 0.8 million acres
- Total CRP contracts: 637,167
- Total farms: 358,026



CRP Enrollment Status

Fiscal Year 2016

- 1.3 million acres enrolled through continuous signup (all continuous signup types)

Fiscal Year 2017

- Currently, offer pace ahead of the FY 2016
- Competition for enrollment will continue to be fierce
- 2.5 million acres expire September 30, 2017

2014 Challenge in Chesapeake Bay

In June 2014, USDA pledged up to \$5 million to help State and local partners encourage enrollment of riparian buffers in the Chesapeake Bay through incentives.

In November 2014, Chesapeake Bay States were asked to develop proposals, not to exceed \$1 million, describing how incentives would be utilized under the State's existing CREP Agreement to increase new enrollment and/or maintain existing enrollment of riparian buffers.

The State partner was required to provide at least a 20 percent matching contribution.



2014 Challenge in Chesapeake Bay

The States of Delaware, New York, Virginia and West Virginia were awarded \$1 million each.

Delaware, New York and Virginia have amended/revised their applicable CREP Agreements for utilizing the additional incentives and State partner contributions.

Delaware approved September 2016

New York approved August 2016

Virginia approved February 2017



2014 Challenge in Chesapeake Bay

Special Incentive Payments for CP22 in Chesapeake Bay

New York:

- \$161,310 in USDA Chesapeake Bay Incentive Payments
- \$0 from State - State incentive paid after practice is installed

Delaware:

- \$29,640 in USDA Chesapeake Bay Incentive Payments to Delaware participants
- \$7,410 additional incentive payments from State



Current Focus On CREP

Signup 50 (beginning October 1, 2016)

- all non-CREP continuous signup offers either:
 - have a start date of October 1, 2017 or
 - was put in batching process
- CREP enrollment continued as normal – no batching, no deferring to October 1, 2017
- CRP-1 Appendix amended to include provision to allow modification of CRP contract at any time to reduce the number of acres enrolled if determined necessary to not exceed 24 million acre cap
 - Acreage enrolled under a CREP Agreement excluded from provision

Current Focus On CREP

- Beginning January 9, 2017, maximum payment rate for continuous signup capped at \$300
 - Payment cap does not apply to CREP
- Beginning January 9, 2017, Signup Incentive Payment (SIP) for certain continuous signup practices were reduced
 - Reduced SIP does not apply to CREP
