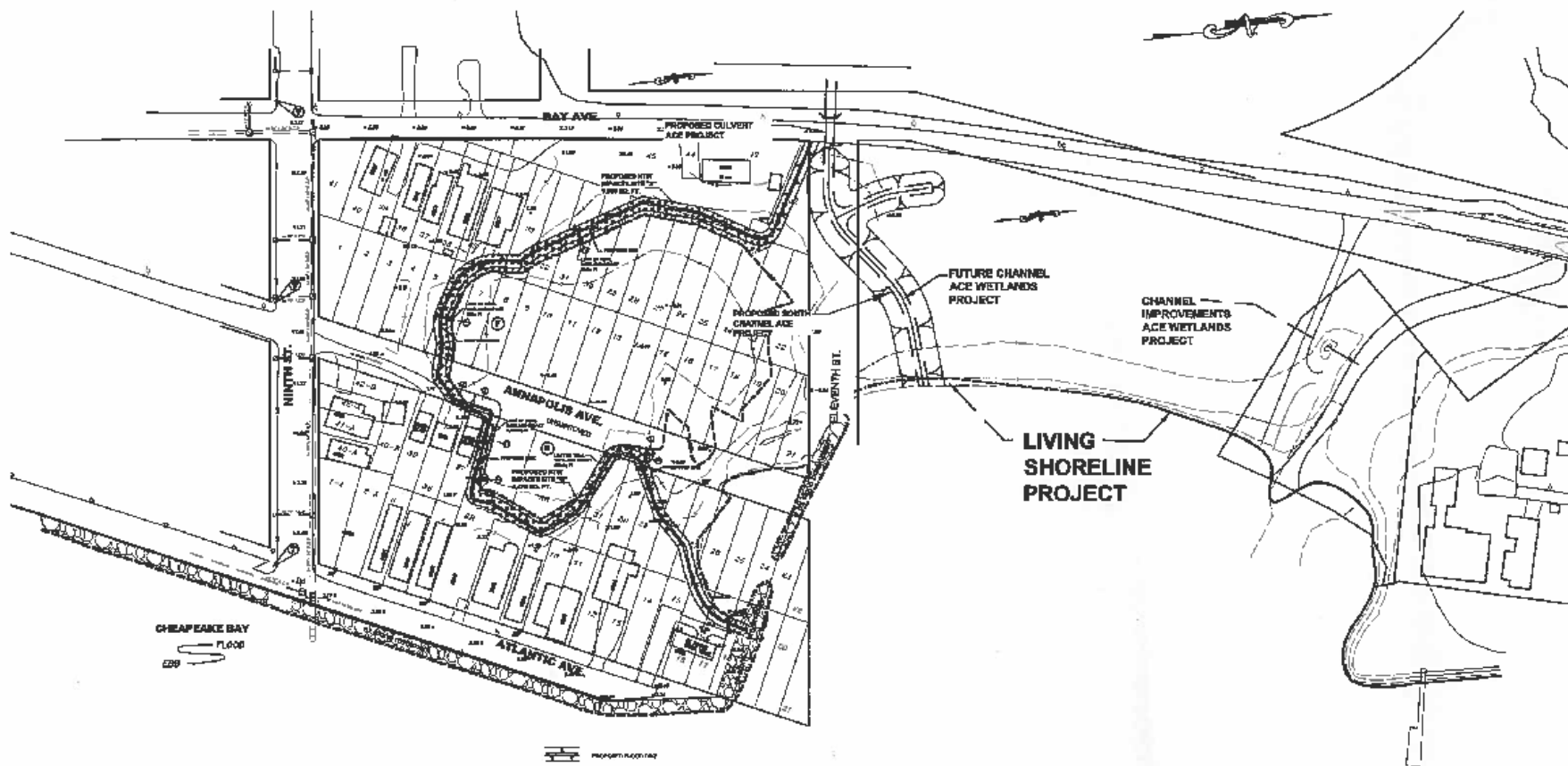




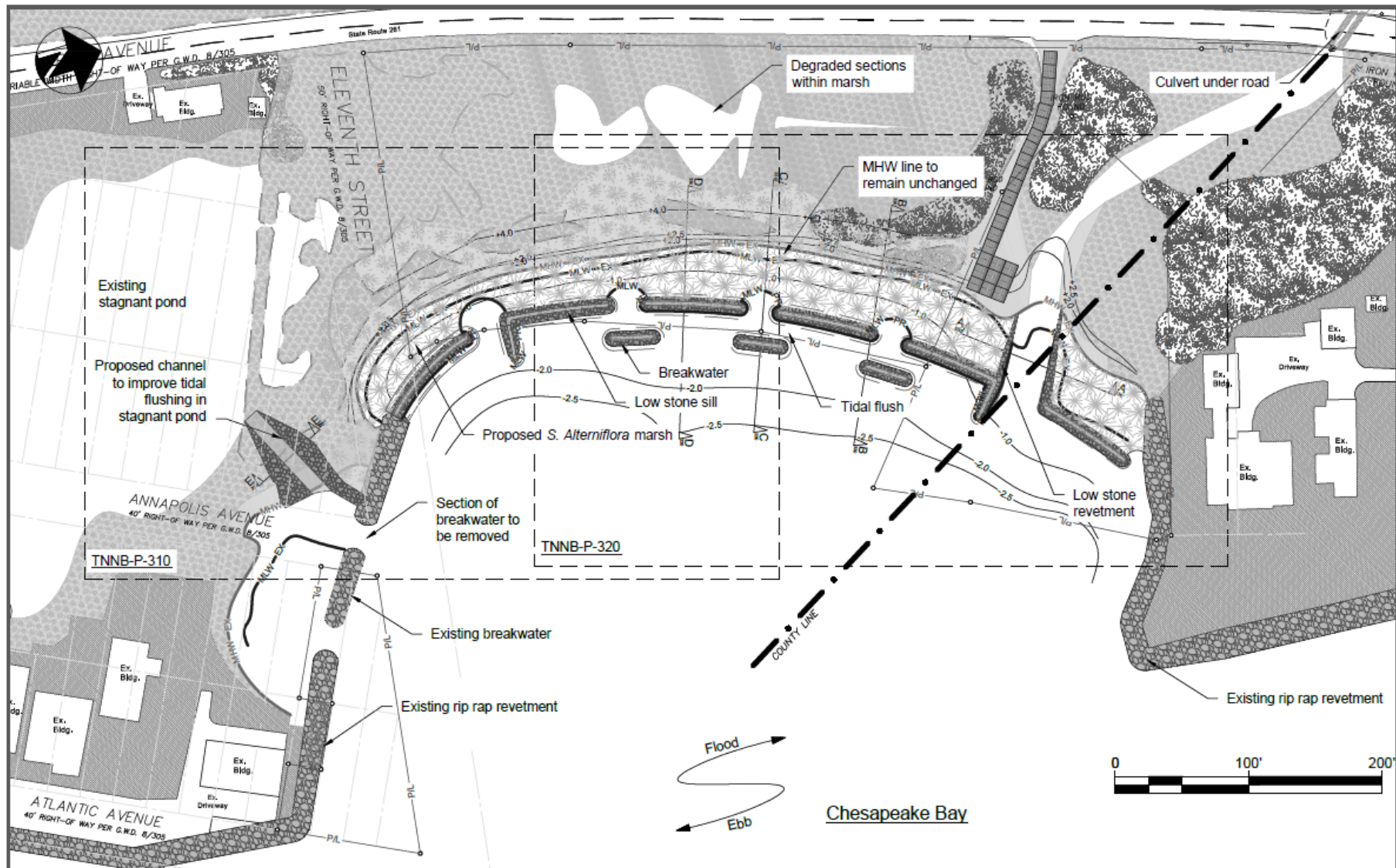








TIDAL WETLAND PROJECTS

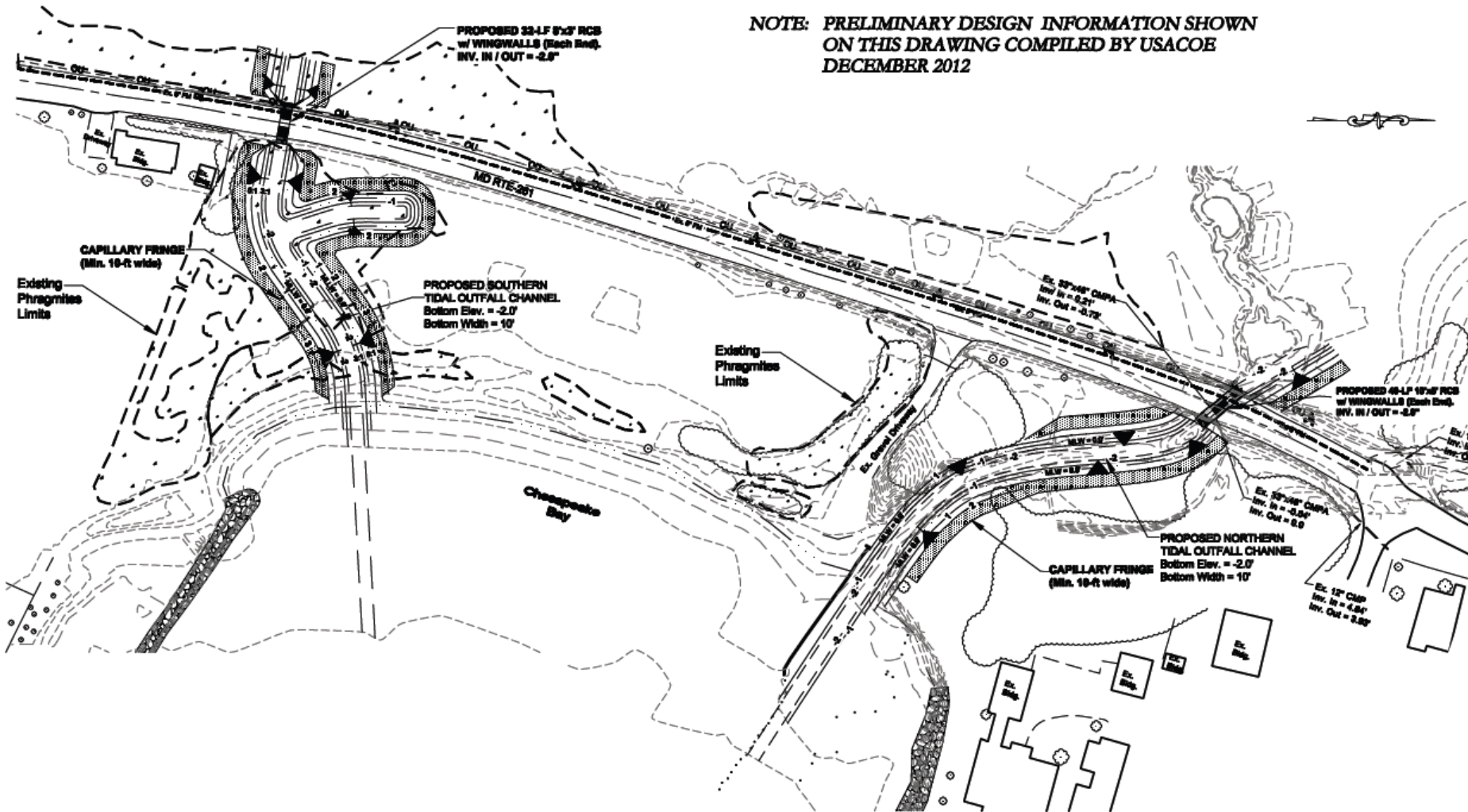

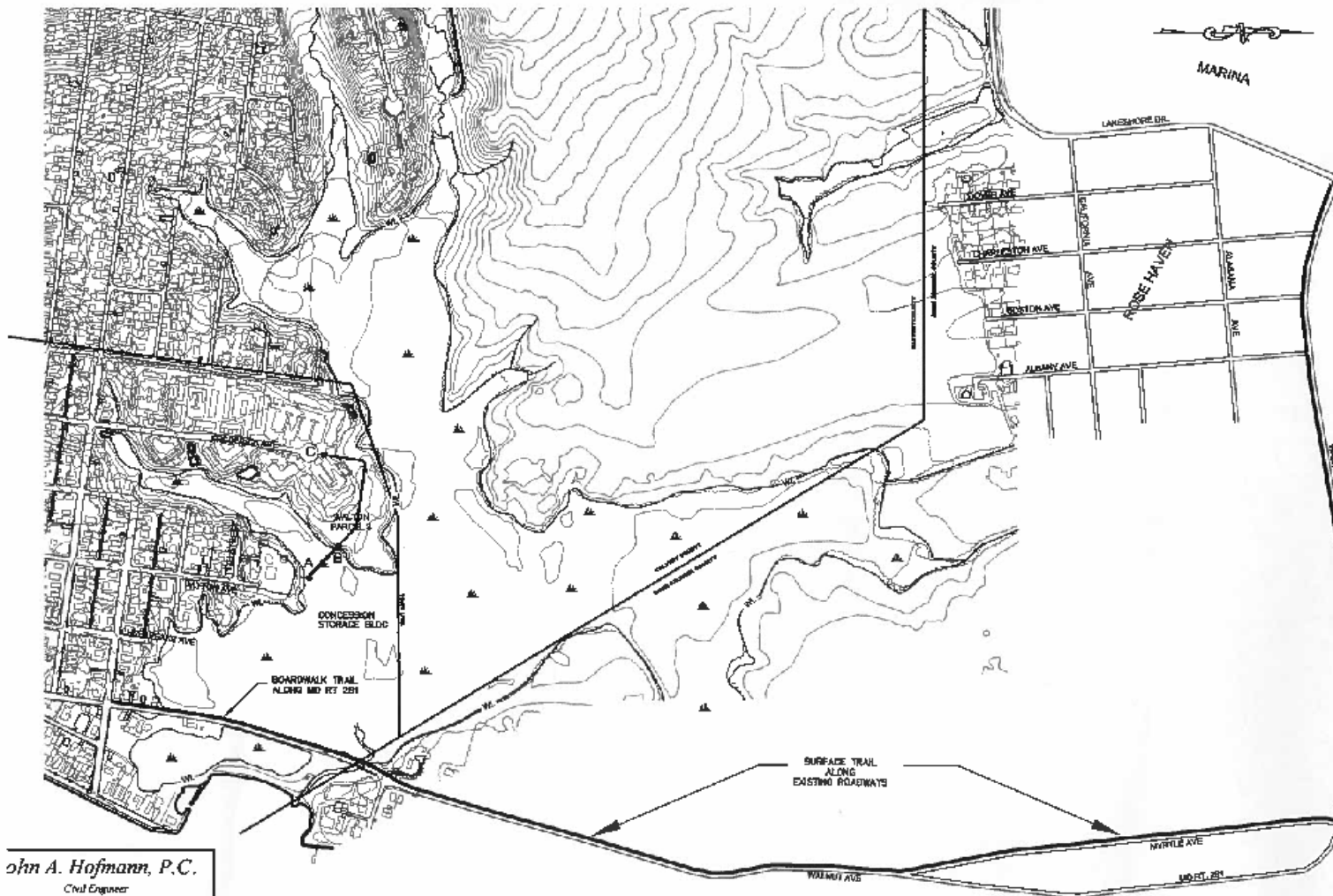

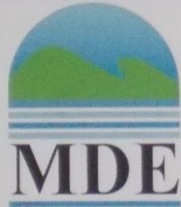
