# Next Steps

## 1. Match jurisdiction & federal agency BMP records

*Use federal agency BMP information & description to identify jurisdiction Tracking ID*

## 2. Identify creditable & non-creditable BMP types

*Flag BMPs that aren't credited to federal agencies, including Erosion & Sediment Control, Agriculture Practices, Forest Harvesting, etc.*

## 3. Upon release of the CAST 2021 Progress scenario, use NEIEN Validation Reports and CAST BMP Input Report to capture BMP errors

*We can track BMPs that have a jurisdiction Tracking ID*

## 4. Complete BMP Credit Evaluation

# Creditable vs. Non-Creditable BMPs

Federal agencies do not receive credit toward TMDL FPGs in CAST for some classes of BMPs because they do not have assigned pollutant loads in those source sectors.
