Management Approach 1: The main focus of this management approach is communication with an emphasis on collaboration and outreach. The action that will implement this approach is

1. The development of materials that will help landowner outreach, specific to each jurisdiction.

For this action, the steps include:

- a. Creating a map outlining ecosystem services throughout the watershed per jurisdiction. (Example: map illustrating species migration, high value lands, protected areas, water quality, etc.). This would also include coordination with the GIS Action team and Chesapeake Conservancy on the development of the plan and scope.
- b. Another step includes spreading awareness of existing communication tools. For example, the Chesapeake Conservation Partnership's Narrative Toolkit. As an example, we can identify one jurisdiction to develop a series of talking points that can be used when communicating with landowners. This template may be used for the other jurisdictions to develop their own similar points.
- c. Action 1 Notes
  - i. Aurelia: Maybe its not creating a map, but create text that can be used to explain the maps. Or is there a role to combine the maps for a watershed wide map.

As an initial step we're seeking GIT funding to compile models and best practices for effective incentive-based and regulatory approaches to protect riparian forest buffers and urban tree canopy, including model policies and easement programs that could be replicated.
