**Action Items from April 2018:**

ACTION: To update PCB story map for NY and Susquehanna, Michelle Williams will follow up with NY on Susquehanna impairment coverage vs PA’s data. **Done. PA data has been updated. No updates from NY.**

ACTION: Mark Richards and Len Schugam will send updated PCB impairment and TMDL data to indicate where TMDLs in progress are pre- and post-public notice. Updated shapefiles will be sent by COB Friday April 13, and final changes and **edits** to the story map will be incorporated by COB Thursday, April 19. The final story map will be displayed at the May 10 Management Board SRS meeting. **Done. Updates to map were incorporated and distributed to the workgroup for review April 27. Further additional edits to MD PCB data will be done prior to the May 9 conference call for presentation to the Management Board on May 10.**

ACTION: The PCB story map will be updated to 2017 rather than 2018. **Done.**

ACTION: The PCB story map will be updated to show 5 panels. PCB TMDLs in development (panel 3) will be split into PCB TMDLs In development (post public notice) and PCB TMDLs planned for development (pre public notice). **Done.**

ACTION: The PCB Consortium proposal will be presented to the Management Board as an ask during the Quarterly Progress Review. Management Board comments and recommendations will be shared with the TCW and the workgroup will discuss next steps at upcoming TCW conference calls. **The PCB consortium has been included in SRS materials submitted to the Management Board. Next steps will be discussed at the June and July TCW conference calls.**

ACTION: TCW feedback requested on the P&P and Research outlines by COB April 20, and on final presentations by COB April 30. **The SRS guides and presentations were submitted to the management Board on Friday, April 27 for the Research and Policy and Prevention outcomes. The logic tables will be submitted to the Management Board by COB Thursday, May 3.**
