Actions and Decisions Summary

DECISION: Agreement Language. Option D – State high level outcome language. Include associated SMART targets bulleted beneath. (Some may not have bullets, need more time).

DECISION: Oyster Fishery: Recommend with changes.

ACTION: Kevin will update oyster fishery outcome language by April 25.

DECISION: Soil Health: The MB refers the Soil Health Outcome recommendation back to the GIT for revision. The MB acknowledges that work under this topic will not be limited to a single GIT but addressed by a cross-partnership group/team.

DECISION: Continue discussion on cross cutting foundational strategies, including braiding knowledge, changing environmental conditions, and consider within the structure and governance work.

DECISION: Consolidate forest buffer and tree canopy outcomes into a new Healthy Forests and Trees outcome.

DECISION: Confirmed the March 27 dispositions on Monitoring and Assessment and Land Use outcome.

DECISION: MB supports continued discussion on the formation of a changing env conditions team. More information will be shared at May retreat.

DECISION: Confirmed the March 27 dispositions on the brook trout, fish passage, stream health, fish habitat outcome family.
