# 2012 BMP VALIDATION

Watershed Technical Workgroup December 3, 2012

## 2011 Validation

- Jurisdictions submitted data in 2011 that failed validation and needed to be corrected.
- CBPO worked closely with the states to correct the validation errors. This was necessary but very time consuming and delayed the progress process.
- All 2011 BMP data needs to be re-checked by states and re-submitted in the correct method again this year.

#### 2011 Validation

- Missing leading zero for HUC 12 and HUC 18
- Missing designation as CBWSOnly
- Segment IDs that do not exist, or exist in a different state
- Incorrect units; e.g., submitting animal units instead of number of systems
- Incorrect BMP; e.g., submitting lagoon covers as alum
- Incorrectly submitting manure transport
- Incorrectly submitting CSO, not CSO, or both
- BMP misspellings
- Submitting BMPs on ineligible land uses or land use groups

## 2011 CBPO Corrections for States

- Corrected invalid segments due to missing leading zero was the largest issue. (Many)
- Allowed AmmoniaEmissionRed as a BMP, when it would be better to report specific BMP such as Alum, LagoonCovers, or Biofilters. (Many)
- Fixed land use groups when BMPs were submitted on invalid land use groups. (VA)
- Changed cover crop BMP from ComCovCropSOW to CoverCropLOW (PA)
- Corrected HUCs that were not in the proper state (DE)
- Rolled up land uses to larger land use groups (CBPO will do this again this year)
