Dear Governor O'Malley,

The Citizens Advisory Committee (CAC) to the Chesapeake Executive Council (EC) recognizes the hard work the Chesapeake Bay Program partners have undertaken in support of creating a new Chesapeake Bay Watershed Agreement (Agreement). Thank you for allowing for additional public review and comment periods as well as responding to the issues that the citizens feel are important inclusions in a regional approach to restoration. We are particularly pleased to see that toxic contaminants, climate change, diversity, environmental justice, and stewardship were included in the final Agreement. We believe the breadth and scope of topics that are in the Agreement are appropriate for a holistic restoration and protection effort across the Bay watershed.

As your citizen advisors, we offer the following comments and points of recommendation for your consideration for the 2014 annual meeting of the Chesapeake Executive Council when the EC members are expected to review the progress of the restoration effort setting the policy for the future of the collective watershed work by signing the Chesapeake Bay Watershed Agreement:

### Points of Recommendation

#### 1. **Emphasize Local Benefits in the Management Strategies**

We acknowledge that the inclusion of the Headwater States of Delaware, New York and West Virginia is a landmark moment in the evolution of the Chesapeake Bay Program partnership. We believe this collective recommitment to the restoration and protection of the watershed provides an opportunity for more citizen engagement through the

improvement of local waterways. The management strategies should be viewed as a tool for local

participation and be developed in a way that clearly demonstrates local benefits and the value of healthy local natural resources. We encourage you to guide the staff who will lead the development of the management strategies to do so in the spirit that a healthy Chesapeake Bay is really the collection of healthy local waters that benefit the entire region's citizenry.

2. **Commit to the Resources Required to Meet the Commitments in the Agreement**

We strongly urge the signatories of the Agreement to provide adequate staff and funding towards the commitments required to meet the goals and outcomes. We encourage you to consider using the management strategies to show how the signatories are prioritizing their commitment to the Agreement by outlining the anticipated funding that will be used to meet outcomes. We also encourage you to take full advantage of federal funding that may be available for meeting the goals. For example, collectively support the designation of the Chesapeake Bay Watershed as a high priority landscape in the Collaborative Landscape Conservation Initiative and the 2014 Farm Bill's Regional Conservation Partnership Program.

3. **Continue with the Good Work on Strengthening Consistency in BMP Verification**

As you may know, CAC has been a strong proponent of the Bay Program partners' work to improve the verification of nonpoint source Best Management Practices (BMPs). The Program has taken great care to respond to the challenges in the 2011 reports issued by the National Academy of Science, *Achieving Nutrient and Sediment Reduction Goals in the Chesapeake Bay: An Evaluation of Program Strategies and Implementation* and the USDA Natural Resources Conservation Service's *Conservation Effects Assessment Project* (CEAP). We acknowledge that the States and District have different approaches to BMP verification and that there are challenges to consistency among the sectors. We also acknowledge that there should be a balance between the need to expend resources on implementation while still ensuring appropriate verification is in place. We believe that this balance can be achieved with a common sense approach. We also believe that a lack of funding for appropriate BMP verification is not a sufficient reason to forgo the steps necessary to ensure citizen confidence in the accounting of restoration and conservation practices. We encourage you to continue to work toward strengthening BMP verification and follow the protocols that afford the jurisdictions defensible credit in the Chesapeake Bay computer model.

The Citizens Advisory Committee supports the goals of the Chesapeake Bay Agreement and the work of the Chesapeake Bay Program partners. We are hopeful that the management strategies will be developed with transparency that demonstrates the signatories' commitment to the watershed effort that will demonstrate local benefits and allow for local participation. We are committed to help where we can to meet the recommendations we've provided for the 2014 Chesapeake Executive Council. Please feel free to call upon us to be of service in our capacity of advisors.

Thank you for your continued leadership to restoring and protecting our National Treasure, the Chesapeake Bay Watershed.

### **Andrew Der:**
