#### 10:35 AM The Next Generation

We have a near-term goal of protecting an additional million acres by 2025; current trends look good, but we still have a ways to go to meet our goal? And we are looking ahead to an ambitious long-term goal of conserving half the watershed in the decades to come. We have a sense of the places that are most important to conserve and those that may be threatened.

We have long-established and successful land protection programs that fueled a wave of land protection since the 1980s. Some are still well-funded; others, less so. The political, economic, demographic and other social factors that spawned the innovations of the 1970s and 80s are different from those we face today and in the future.

In this working session we will explore and envision the next generation of conservation innovation needed to fuel the achievement of our goals.
