Background: In October 2022, the [Chesapeake Executive Council](#) (EC) charged the [Principal's Staff Committee](#) (PSC) with preparing 'recommendations that continue to address new advances in science and restoration, along with a focus on our partnership for going beyond 2025.' The PSC established a [Beyond 2025 Steering Committee](#) (the Committee) to meet this charge before the EC meeting in December 2024. The Committee includes broad representation from across the Partnership and underwent a rigorous process to draft a report for leadership to consider. The draft report is open for public feedback from July - August 2024.

The Local Government Advisory Committee (LGAC)'s mission is to share the views and insights of local elected officials with state and federal decision-makers. The Local Government Forum is an annual problem solving meeting hosted by LGAC in collaboration with the Alliance for the Chesapeake Bay and the National Fish and Wildlife Foundation. This year's forum will convene a broad group of local elected officials, appointed officials, senior staff, and local government association staff from around the watershed to discuss the draft Beyond 2025 Steering Committee report and its possible implications for local governments. Through facilitated discussions, the forum will collect feedback to inform LGAC's recommendations to the Chesapeake Bay Program leadership for their consideration related to the future of the watershed restoration effort.
