EC Charge to PSC

- Carin and Lucinda Power developed a draft resolution charging the PSC to develop a critical path forward to meeting the outcomes under the *Chesapeake Bay* Watershed Agreement leading up to and beyond 2025.
- Under the science category, Carin added priorities raised by the PSC during their August 29 CAST meeting.
- O The suggestion was made to include options for communicating our successes under the "Restoration" section.
- We agreed the language in the resolution should be changed to account for the possibility of adding new goals after 2025 in addition to reviewing whether current goals were completed or need to be renewed.
- O We agreed that the "Partnership" section should be kept in the resolution with the caveat that we include language indicating that a programmatic evaluation is aimed for post 2025 and that the focus until 2025 is on attaining the Watershed Agreement's goals if possible.
- We need to be careful that the resolution does not appear to sound like we are giving up on meeting our 2025 targets.
- Maryland noted that "partnership" is important to keep reflecting our continued commitment to working together.
- Carin will update the resolution to include feedback from team members and share the updated draft with the planning team by Friday, September 9, 2022 to gather additional comments.
- We will plan to add discussion of the resolution to the agenda for the private lunch.
 Depending on the outcome of that discussion, we can update the Administrator's remarks to reflect the EC's decision in the public meeting.
