10:20 Programmatic Milestones for the Urban Sector. Katherine Antos, CBPO, Attach B

Earlier this year, EPA conducted its two year review of programmatic milestones for each of the Bay states to determine progress made by each Bay state to create the programmatic capability to meet their pollutant load reductions in the urban sector. Katherine will present highlights from this state by state review, followed by questions and answers.

Karl Berger will briefly summarize the scientific consensus achieved on urban land use loading rates at the April workshop, and subsequent workgroup meetings. The full workshop report will be distributed to members soon.
