## Ag Advisory Committee Meeting, Gettysburg PA

The AAC met in person on August 28, with several site visits the day prior

AAC members were familiarized with how agriculture is represented in the model, as well as the protocols that are in place to get credit for new BMPs or existing BMPs. Discussions involved how nutrient values are determined and applied in the model.

We developed a set of comments regarding the draft revised Chesapeake Bay Agreement:

- Many of the comments were a reflection on the fact that, while ag is responsible for 50% of the remaining nutrient load reductions, the ag community was absent from the agreement itself.
- The group also thought that it was important to recognize that the success of the ag sector to meet its goals is dependent on economically viable farms, and desired that strategies to meet water quality goals consider the impact on farm profitability.

### Ag Advisory Committee Meeting, Gettysburg PA

The AAC decided to set up three subcommittees, one of which is a Technical Subcommittee.

- At the start, the purpose of that group is to help the AAC to work through some of the
  questions and issues that were identified during the meeting. They'll work with the
  Ag Modeling Team and Ag Workgroup, determine how to facilitate exchange of
  information between different entities, and would consider how soil health practices
  should be included in the model.
- Over time, this same group will look at new technologies that have the greatest potential to impact water quality and policies or strategies to advance those practices, as well as how to move the conversation in the ag community from a yield-driven approach to a profit-driven approach.
