

Beyond 2025 Public feedback period

What is Beyond 2025?



The Beyond 2025 Steering Committee advises on the development of recommendations to meet the Chesapeake Executive Council charge to the Principals' Staff Committee on charting a course beyond 2025.

What is the Executive Council Charge?

Adopted by the Executive Council in October 2022, the charge directs the Principals' Staff Committee to recommend a critical path forward that prioritizes and outlines the next steps for meeting the goals and outcomes of the *Watershed Agreement* beyond 2025.

Executive Council Charge to the Principals' Staff Committee: Charting a Course to 2025 and Beyond
Adopted October 11, 2022

As the Chesapeake Bay Program (CBP) partnership nears the 2025 date that the partnership set for several of the goals and outcomes under the *Chesapeake Bay Watershed Agreement* (*Watershed Agreement*), there are many successes to celebrate. At the same time, emerging issues and changing conditions (e.g., climate change, growth, new scientific data) have impacted the levels of effort needed to meet our collective restoration priorities. We, as a partnership, remain committed to using the best available science in restoring the Chesapeake Bay as we accelerate toward the deadline and anticipate continued progress post-2025.

Thus, this Executive Council charges the Principals' Staff Committee (PSC) in recommending a critical path forward that prioritizes and outlines the next steps for meeting the goals and outcomes of the *Watershed Agreement* leading up to and beyond 2025. The PSC is to report back to the Executive Council at our 2023 annual meeting with recommendations on how to best address and integrate new science and restoration strategies leading up to 2025. At our 2024 annual meeting, the PSC is to prepare recommendations that continue to address new advances in science and restoration, along with a focus on our partnership for going beyond 2025.

What has happened so far?

- The Steering Committee determined the scope and breadth of what should be undertaken to meet the Executive Council charge and developed a plan to complete the work.
- Five small groups of subject matter experts were formed to develop findings to support the recommendation the steering committee will make to the Principals' Staff Committee.
- A contractor was retained to complete an independent evaluation of the partnership.



Proposed Agreement Recommendation and Timeframe

By 2025 Executive Council Meeting:

- Focus on high-level updates to the Watershed Agreement: Vision, Preamble, Principles, Goals and Management Strategies.
- Maintain focus on core: clean water, vibrant living resources & habitats, healthy landscapes and engaged people.
- Recommend adding "Conservation" to our mission statement.
 - Science. Restoration. Conservation. Partnership.
- Reaffirm commitment to partnership and continued collaboration.

Proposed Agreement Recommendation and Timeframe

Starting at the 2026 Executive Council meeting:

- Review, refine and refresh outcomes.
 - Remove outdated dates and metrics.
 - Review completed outcomes, set plan for maintenance.
 - Add language to reflect emerging challenges (i.e., climate change).
 - Ensure outcomes have time-bound measurable targets.
- Commit to a renewed partnership.
