Revised Chesapeake Bay Watershed Agreement signed by Executive Council



Chesapeake Executive Council

- the governors of *Maryland, Pennsylvania, Virginia, New York, Delaware, and West Virginia*,
- the mayor of the *District of Columbia*,
- the administrator of the *U.S. Environmental Protection Agency (EPA)*,
- and the chair of the *Chesapeake Bay Commission*.

Chesapeake Bay Watershed Agreement



Revised Watershed Agreement

There were 31 outcomes in the 2014 Agreement. After the outcome disposition process, there are 4 goals, 21 outcomes, and 47 targets.

Targets


Targets contribute to achieving the Outcome and are as specific, measurable and time bound as possible.

Chesapeake Bay Program Structure




New Structure around revised goals and outcomes

Management Strategies

Transitioning from 31 Management Strategies to a strategic plan consisting of a collaborative introduction and executive summary, followed by a Management Strategy for each goal (4).

1. GIT Chairs need to be confirmed (Management Board Meeting 2/12/26)
2. GIT Chairs will pick group to work on Management Strategies
 - Principal Staff Committee agreed draft Management Strategy template will be developed by March, with final approval no later than June
 - GIT Chairs assume responsibility for drafting the Management Strategies

CAP WG Next Steps

Indicators/Targets

Water Quality, Standards Attainment, and Monitoring Outcome: Targets 2 and 3

Discussions are ongoing with STAR/Indicator Team and Management Board on what is an indicator.

- Develop and expand partnership-approved approaches for assessing whether water quality criteria are being met for all designated uses. For dissolved oxygen criteria, establish an approved method by 2028 and apply the method for data analysis and reporting by the end of 2030.
 - **STAR/Indicator Team suggestion:** This target does not need an indicator. Discussion still needed on where we track this progress for the partnership.
- Maintain or exceed the rate of improvement in the water quality standards attainment indicator relative to the 1985-2022 baseline.
 - **Continue utilizing Water Quality Standards Attainment indicator**
 - **STAR suggestion:** How can we better showcase the progress of attainment and overall comprehensive story of clean water? Adding figures and narrative about attainment deficit, hypoxia forecasting?
