

Chesapeake Bay Program Update: Beyond 2025


Toxic Contaminants Workgroup Meeting



The 2024 Executive Council Charge:

"...direct the Principals' Staff Committee to complete the following by December 1, 2025:

- Revisions to the 2014 Chesapeake Bay Watershed Agreement with modifications to the existing vision, principles, preamble, goals, and outcomes..."
- 2. ...Recommending this simplified and streamlined partnership structure and processes to the Executive Council in as much detail as possible..."
- Subsequent changes which incorporate this revised structure and processes into the Governance and Management Framework for the Chesapeake Bay Program do not need to occur until June 2026.



Timeline for the rest of 2025

May 7 & 8

MB finalize recommended Outcome revisions; discuss any changes necessary for Goals and Management Strategies based on Outcomes status; discuss any changes necessary for structure and governance work.

June 12

MB review PSC direction and approve final recommendations for public feedback

July 1

60-day public feedback period begins

August 14

Initial recommendations for structure and governance work; initial feedback review from partner engagement period.

September 1

Conclusion of public feedback period

October 9

Propose changes to Watershed Agreement revisions based on public feedback; final structure and governance recommendations.

November 18

PSC approve final Watershed Agreement revisions and final structure and governance recommendations in preparation for EC meeting.

May 23

PSC review MB's recommended Outcome revisions; discuss possible changes to Goals and Management Strategies; discuss any changes necessary for MB structure and governance work. Meeting follow-up; Chair's team will manage and circulate feedback.

July 10

MB structure and governance work.

Week of June 23

PSC short meeting for PSC to approve all *Watershed Agreement* changes for public release.

August 20

Review MB's structure and governance recommendations, provide feedback; initial review of feedback from partner engagement period.

September 11

MB begin to review, organize and address public feedback.

November 6

MB approve final Watershed Agreement revisions and final structure and governance recommendations in preparation for EC meeting.

December 11

Final preparation for EC meeting

May 23 PSC Decisions

- Approved revisions to Watershed Agreement for public feedback:
 - Proposed revisions to the Chesapeake Bay Watershed Agreement's Vision, Preamble, and Principles.
 - Recommended language for the Agreement's outcomes, which were language proposed at the May 7-8 Management Board Retreat.
 - Revised goal structure under the Agreement, as well as proposed changes to the Management Strategies section of the Agreement.
- Approved GIT 6's continued work on structure and governance as part of fulfilling the 2024 Executive Council charge.
- Agreement on the intent of the draft PSC response to the January 2025 resolution from the Indigenous Conservation Council (ICC). More work needed to finalize. Will be on the June meeting agenda.

TCW Outcome Language Advanced by PSC

- Outcome Disposition: Update
- Outcome Name: Toxic Contaminants Mitigation Outcome
- Outcome Language: Reduce the amount and effect of toxic contaminants, such as PCBs, plastics, mercury, and PFAS, on the waters, lands, living resources and communities of the Chesapeake Bay watershed by facilitating an increased understanding of their impacts and mitigation options.
 - Target Language: Promote continuous information sharing between researchers, program managers and policymakers on the lessons learned, best practices and most up-to-date science, policy, and communications around the toxic contaminants impacting the Chesapeake Bay watershed.

Next Steps for the Watershed Agreement

Date of Action	Deliverable / Decision
July – August 2025	60-day public review and engagement period for updated Watershed Agreement
Sept – Oct 2025	PSC reviews public feedback and revises Watershed Agreement as needed
November 2025	PSC approves final updated Watershed Agreement for Executive Council consideration
December 2025	Chesapeake Executive Council holds annual meeting; reviews and approves updated Watershed Agreement

- Comments will be collected, reviewed and integrated as appropriate into the updated Agreement.
- All comments received, as well as a redlined version of the updated Agreement will be posted online at <u>chesapeakebay.net/beyond2025</u>.
- The final updated Agreement will be reviewed by the Management Board and will inform the Principals' Staff Committee recommendations to the Chesapeake Executive Council.
