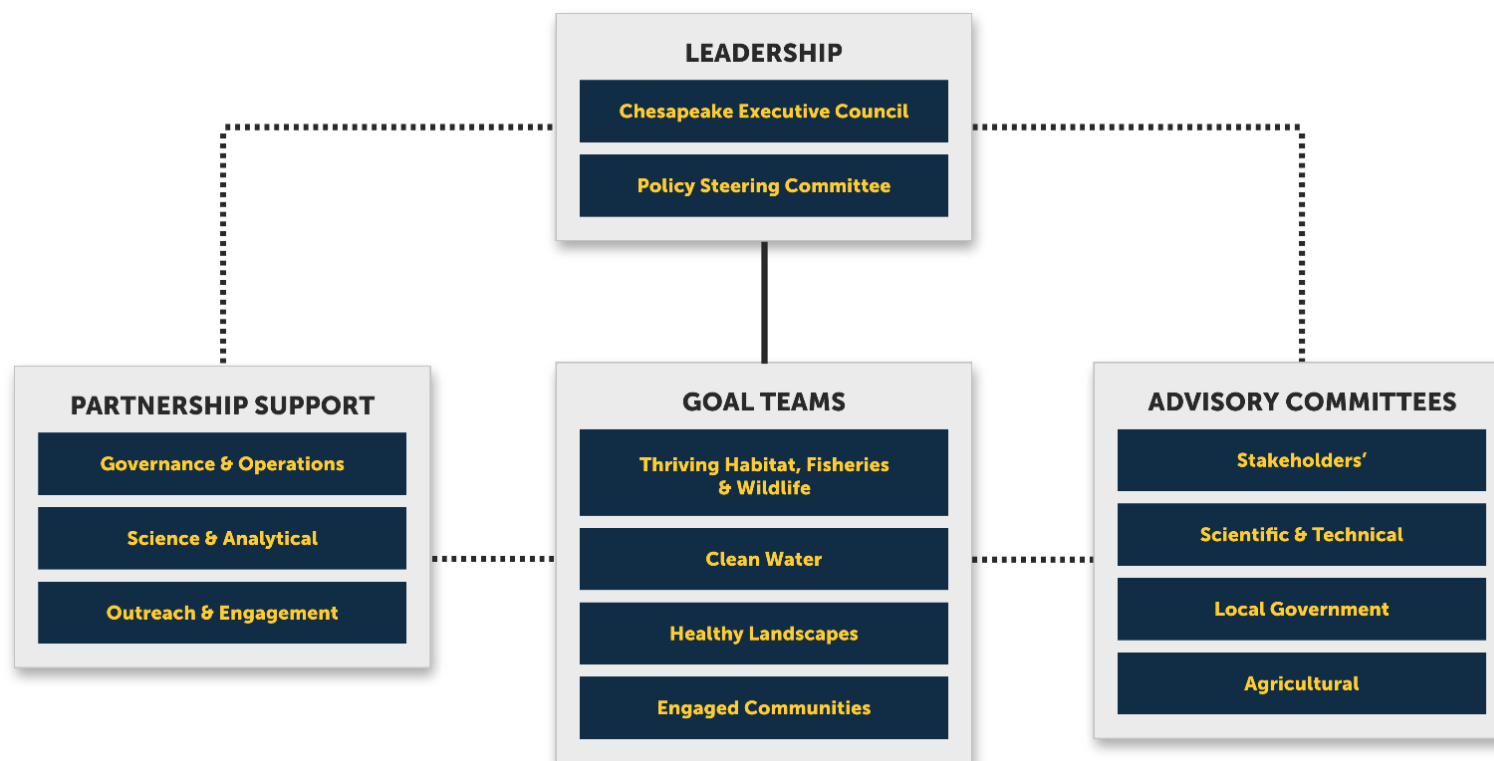

Chesapeake Bay Program Organizational Structure

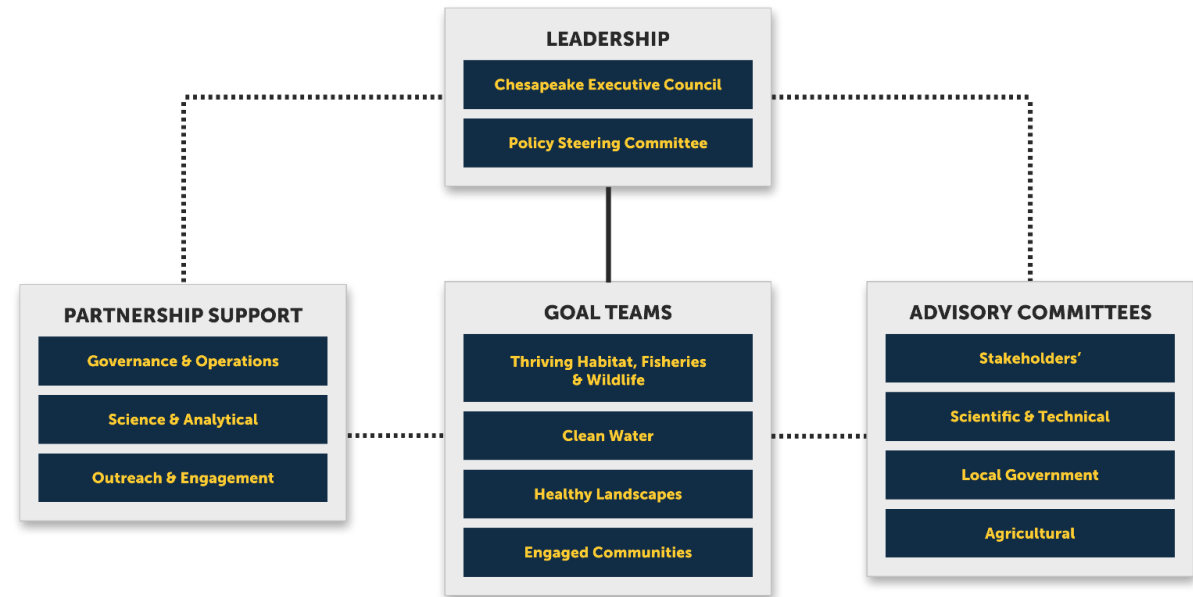

Explicit Decision-Making Frameworks

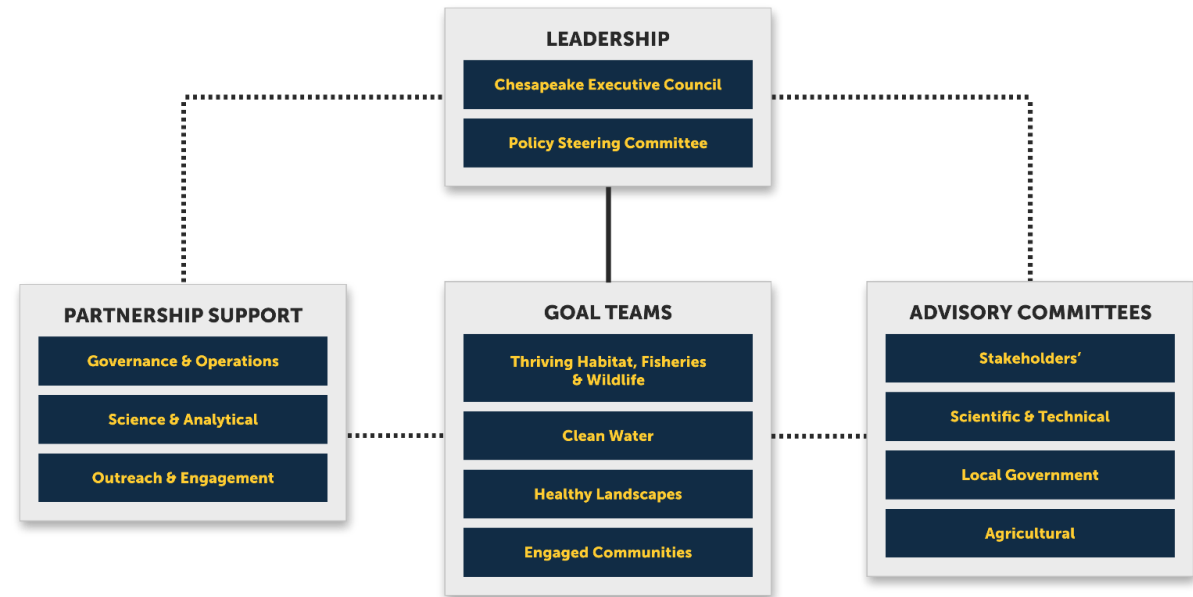
- Standardized where appropriate but also tailored to a body's membership and purpose.
