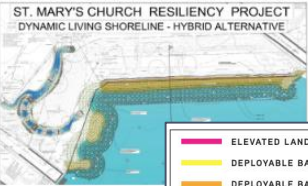

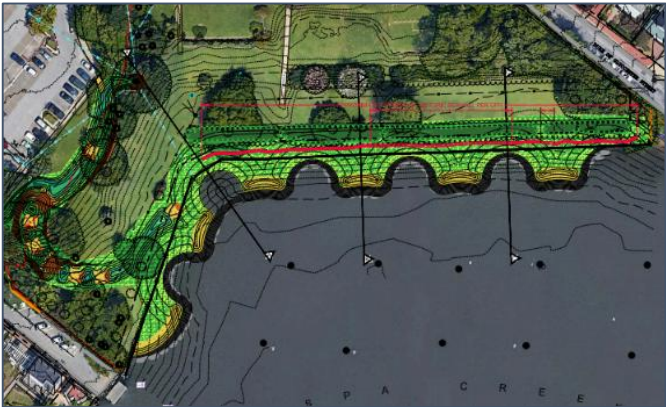


### St. Mary's Living Shoreline Project

**Background**  
The property on which St. Mary's Church and Rectory are located was given to the Redemptorists in 1852 by four granddaughters of Charles Carroll of Carrollton, the only Catholic signer of the Declaration of Independence, whose birthplace and long-time home is on the property. With its distinctive landscaping and buildings of historical importance, the property remains one of the signature parts of this historic city. However, with sea level rise and associated climate change impacts, this special place is at risk. The current wooden bulkhead already shows signs of erosion and failure from high tides, overtopping and waves. The effectiveness of the bulkhead will only worsen as its deterioration quickens with rising sea levels and a shoreline that is battered by increasing severity of storms. The church's commitment to environmental stewardship as well as the preservation of the land's history led them to pursue the installation of a living shoreline before important historic features are lost.

**Living Shoreline Project**  
St. Mary's Church, with funding from the Department of Natural Resources, has developed a living shoreline design to help protect this historic property as well as further strengthen the resiliency of surrounding landscapes. The proposed work includes removing a portion of the existing wooden bulkhead, grading the slope, bolstering the land with stone and native grasses, and installing a Regenerative Stormwater Conveyance to slowdown and treat stormwater. The living shoreline will become stronger and more resilient to changing environmental conditions over time. This dynamic practice can also adapt to rising sea levels and the erosive energy that comes with higher tides.

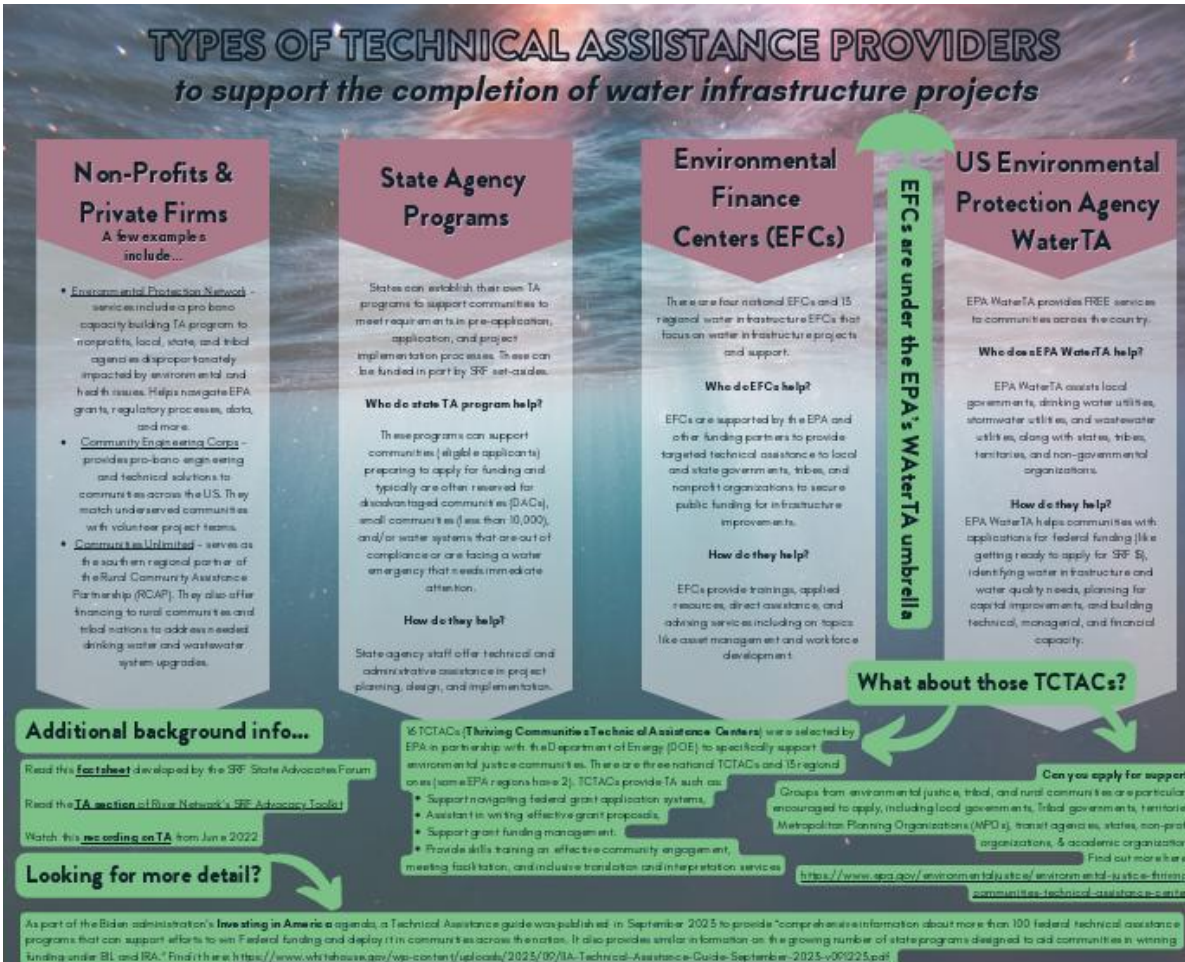
