Final Recommendations in Response to PSC Charges on CAST (9:05 a.m. – 10:00 a.m.) During the August MB meeting the Water Quality Goal Team presented its recently approved recommendations in response to the Principals' Staff Committee's August 2022 charge to resolve actions related to the updates to the Chesapeake Assessment Scenario Tool (CAST)2023. The WQGIT approved: 1) Option 1 for the Phase 6 CAST update schedule; 2) the short-term, interim resolutions to fertilizer data concerns that were developed by the Fertilizer Expert Group in response to the PSC Decision #2; and 3) the Watershed Technical Workgroup's (WTWG) recommendations in response to PSC Decision #3 charge regarding illogical results (data abnormalities) and safeguards to prevent data analysis errors. Lee and team will review recommendations and seek final concurrence. The MB was asked to provide comments, edits and questions prior to this meeting.

<u>Requested action</u>: Seeking concurrence with the WQGIT's recommendations and to send forward to the PSC for final resolution.
