


#### **Delaware**

  - Seaford is no longer operating their CSS, moving their stormwater controls to MS4
  - 13,865 Hectares in the watershed and adjoining counties

No new boundaries: used existing Phase 6 boundaries




#### Maryland

  - Phase 2 MS4 Municipalities






#### **New York**

  - Changes expected sometime in the future, timeline unclear.






Updated boundaries using State-provided data portal




# Virginia

  - The timeline for updates needs to be revised





#### **Delaware**


 Seaford is the only CSS we have for Delaware, and it is classified as a former combined sewer system.

 CSS area remains current and unchanged from version 6.







#### Maryland






# New York has two current CSS communities, Binghampton/Johnson City and Elmira.









- Pennsylvania has 32 current and former CSS communities.


- Virginia has 3 current and 1 former CSS
