### ***Discussion Notes:***

- Ducks Unlimited
  - NFWF Grant NWI
  - Fish and Wildlife Cooperative Agreement
  - **Notes:**
    - Nancy Schumm announced that, following discussions held approximately 18 months prior, updating outdated National Wetlands Inventory (NWI) maps was identified as a workgroup priority. Many NWI maps in the region date back to the 1980s and pre-date modern mapping technologies such as LiDAR.
    - A partnership led by Ducks Unlimited, with Howard County, Montgomery County, and Carroll County (MD), successfully applied for and received a National Fish and Wildlife Foundation (NFWF) small grant to update NWI mapping in these jurisdictions. All documents have been signed and the project is officially underway.
      - Geographic scope: All wetlands within Carroll, Howard, and Montgomery Counties, Maryland.
      - Additional detail: Montgomery County is contributing matching funds to support higher-resolution mapping (down to 0.01 acres).
- **Requested Action:** Habitat Tracker projects due February 13th.
  - **Notes:**
    - Reminder of recent request from Emily Young, Habitat Data Manager, for jurisdictions to submit habitat tracking information by February 13. Chris Guy clarified that the request was targeted to specific jurisdictional coordinators and not all Wetlands Workgroup members.
- Tidal Wetlands Strategic Plan Update.
  - **Notes:**
    - Robert McAfee (Chesapeake Bay Trust) and Matthew Robinson (EPA) provided a status update on the Tidal Wetlands Strategic Plan, which originated from the Wetlands Workgroup's 2022 Action Plan. The strategic plan is in final editing stages, with near-term plans to distribute it to the full Wetlands Workgroup for review. Supporting appendices on landowner and community engagement and sustainable programming are nearing completion, while the developing capacity appendix remains in progress with an anticipated completion in April 2026.
- Whitepaper Update
  - Final draft will be released after today's meeting.
  - **Requested Action:** provide a red flag review by February 21st.
  - Final whitepaper published on workgroup website early March.
  - **Notes:**

- Pamela Mason provided an update on the Wetlands White Paper documenting how wetland terms and practices are currently used across the region. The paper is intended as a non-regulatory reference to support consistent reporting of wetland practices.
  - Action: A cleaned review draft will be distributed for red-flag review, with comments requested by February 21, 2026.
  - PA requested a copy of the previous version to compare against the current draft.
- Waterbirds Vice-Chair Update
  - Notes:
    - Chris Guy announced that recruitment is underway for a Water Birds Vice Chair to lead development of the water birds component of the wetlands outcome. Interviews are in progress, with a selection anticipated by the end of January 2026. The Vice Chair will support definition of indicators and alignment with existing monitoring networks.

**Wetlands Outcome:** Restore, create, enhance and protect wetlands to support people and living resources, including waterbirds and fish, and provide water quality, flood and erosion protection, recreation and other valuable benefits to people.

- Restore or create at least 3,000 acres and enhance 15,000 acres of tidal wetlands by 2040, focusing on habitats that support populations of waterbirds and represent healthy wetlands across the watershed.
- Restore or create at least 3,000 acres and enhance 15,000 acres of nontidal wetlands by 2040, focusing on habitats that support populations of waterbirds and represent healthy wetlands across the watershed.

- Notes:

- Pamela Mason and Chris Guy led discussion on the new Wetlands Outcome, which was formally adopted by the Chesapeake Bay Program Executive Council in December 2025.
- Key points:
  - The revised outcome integrates water birds directly into the wetlands outcome rather than as a separate target.
  - The outcome addresses both tidal and non-tidal wetlands and emphasizes restoration, creation, and enhancement activities.
  - Numeric targets were adjusted during the approval process; final targets are considered achievable and intended to support adaptive management rather than aspirational overreach.
- Pamela Mason emphasized that the revised outcome reflects a balance between ambition and feasibility and thanked workgroup members and Management Board champions who supported adjustments to strengthen the final language.
- Questions were raised regarding how water birds are defined under the outcome. Leadership clarified that:
  - “Water birds” is intentionally broad and not yet prescriptively defined.
  - The intent is to include multiple guilds (e.g., waterfowl, wading birds, marsh birds) rather than a single species such as black duck.
  - Future work will define indicators using existing monitoring networks (e.g., State Wildlife Action Plans, established bird surveys).

**Background and Context:** Maryland DNR released a [RFP](#) seeking living shoreline projects on the Lower Eastern Shore that protect significant marsh acreage. This funding comes from the EPA Climate Pollution Reduction Grant we received to advance natural climate solutions on the shore. **Implemented projects under this Initiative will count towards meeting Maryland's goals for the Wetland Outcome for the Chesapeake Bay Program Watershed Agreement!**

  - **Roots for Resilience Initiative (MD DNR):** Sarah Koser and Morgan Corey (Maryland Department of Natural Resources) presented an overview of the newly launched Roots for Resilience: Strong Roots for a Changing Landscape initiative. The initiative is funded through the Atlantic Conservation Coalition under the Climate Pollution Reduction Act and focuses on carbon sequestration, coastal resilience, and wetlands restoration, particularly on Maryland's Lower Eastern Shore.
  - Maryland DNR will implement approximately \$43 million in funding over five years, with commitments including tidal marsh restoration, living shorelines, tidal reconnectivity projects, coastal resilience management plans for private landowners, and forest carbon initiatives.
  - The initiative will contribute directly to Maryland's wetland outcome reporting under the Chesapeake Bay Program.
