

#### CHESAPEAKE BAY PROGRAM BEYOND 2025 STEERING COMMITTEE RECOMMENDS:

- 1. AFFIRM THE PARTNERSHIP'S COMMITMENT TO WORK TOGETHER IN PARTNERSHIP TO MEET THE GOALS OF THE WATERSHED AGREEMENT. DIRECT PARTNERSHIP TO CONTINUE IMPLEMENTATION OF EXISTING GOALS. DIRECT PSC TO MAKE EVERY EFFORT TO PROPOSE SPECIFIC AMENDMENTS TO THE AGREEMENT, INCLUDING OUTCOMES, BY END OF CALENDAR YEAR 2025
- 2. KEEP THE PARTNERSHIP STRONG. **SIMPLIFY AND STREAMLINE STRUCTURE AND PROCESSES.**

#### SCIENCE

- • Monitoring, Modeling, Analysis
- Decision-making, resource allocation, communication
- Knowledge gaps: Climate, land use, social science, toxics and emerging issues

#### RESTORATION AND CONSERVATION

- Elevate conservation and nearshore habitats
- Review all goals, outcomes and strategies
- Holistic approach to maximize benefits

#### PARTNERSHIP

- • Streamline
- Build capacity through local networks
- • Strengthen relevance to all communities
- Communication and transparency

## POLLUTION TO ONGOING WORK

- November 7 Clean Water Cohort presents to Management Board on Water Quality WIP progress, Toxics and Water Quality Standards for their quarterly review
- Management Board retreat during mid-November will include priority setting and plans to achieve phase 2 (a review of the outcomes with an impact assessment, assigning high level recommendations, looking at structure and governance)
- Principal Staff Committee will be leading the effort on amending the agreement and setting priorities for Management Board
- Phase 2 meetings of Principal Staff Committee,
   Management Board, goal teams or small groups as assigned during 2025

- Plastic Pollution Action Team could sunset or continue
- There are clear opportunities to embed the results of the action team work in various parts of phase 2
- Explore opportunities to connect with the living resources and people experts with this knowledge
- Progress can be made on plastics without it being a prescribed goal or outcome in the revised agreement
- Connect to the things people care about
- Aim for multiple benefits and plant seeds
