On March 24, the CBP's Scientific and Technical Advisory Committee (STAC) released a workshop report: "Rising Temperatures in Chesapeake Bay and Watershed; Management Responses to Ecological Impacts." The report outlines key management and research recommendations, the causes and effects of rising water temperatures, and actions for moving forward. A high-level overview of the report findings will be followed by a discussion about possible partnership responses to those findings.

b. STAC CESR Report: Key Findings and Plans for a Partnership Response (30 minutes)

On May 9, the CBP's Scientific and Technical Advisory Committee (STAC) released its final independent report: "Achieving Water Quality Goals in the Chesapeake Bay: A Comprehensive Evaluation of System Response (CESR)." Four years in the making, the report is an analysis of why progress meeting the Chesapeake Bay Total Maximum Daily Load and achieving healthy water quality standards in the Bay has been slower than expected. It also identifies opportunities for improving the effectiveness of the Bay Program's water quality management programs and living resource response.

IV. Next Steps for the Watershed Agreement: Reaching 2025 and Beyond 2025

The Executive Council, at its October 2022 meeting, charged the PSC with recommending a path forward that prioritizes and outlines the next steps for meeting the goals and outcomes of the Watershed Agreement leading up to and beyond 2025. Planning for how to implement the EC's charge are underway and being overseen by the Management Board.

Steering committees have been formed for "Reaching 2025" and for "Beyond 2025." The Reaching 2025 Committee has focused efforts on developing an assessment and communications plan with a report due to the Executive Council during their October 2023 meeting. The Beyond 2025 steering committee met for the first time on June 22 to discuss plans for developing a workplan to meet the Beyond 2025 EC Charge; establish the committee's steering process; and determine approaches for meaningful public dialogue. Updates will be provided by both groups.
