**10:15am      Conversation with new PSC Chair.....The Honorable Jessica Shirley**  
**Secretary, Pennsylvania Department of Environmental Protection**

Secretary Shirley will offer remarks on Pennsylvania's priorities for advancing shared Chesapeake Bay watershed goals, her perspectives of upcoming changes to the CBP's structure and governance, and the draft Principals' Staff Committee (PSC) response to the Stakeholders' Advisory Committee's 2025 letter of recommendations to the Executive Council.

*Background and Context:* Jessica Shirley serves as the Secretary for the Pennsylvania Department of Environmental Protection (PA DEP), playing a pivotal role in the guidance of the department in its mission to protect and preserve Pennsylvania's environment while fostering sustainable and equitable practices.

At the 2025 Executive Council (EC) meeting, Pennsylvania Governor Josh Shapiro was elected as 2026 EC Chair. Secretary Shirley represents Governor Shapiro by serving as the Chair of the PSC. The PSC works on behalf of the Executive Council to translate their vision into policy and action. Members of the PSC include high-level state and federal leaders.

**VA Secretary of Natural and Historic Resources**

Secretary Bulova will offer remarks on Virginia's plans and priorities for advancing shared Chesapeake Bay watershed goals.

*Background and Context:* David Bulova was recently appointed as Secretary for Virginia's Natural and Historic Resources to advance VA Governor Spanberger's environmental priorities. The Secretary oversees five agencies that protect and restore the Commonwealth's natural and historic resources. Secretary Bulova represents Virginia on the PSC. Secretary Bulova is a former House Delegate of Virginia's 11th District and twice served as chair of the Chesapeake Bay Commission.

Doug will offer a 15-min briefing followed by Q&A and Committee discussion.

*Background and Context:* The 2025 Executive Council approved the PSC's recommendation to restructure the CBP organization to enhance the efficiency, coordination and effectiveness needed to implement the *Chesapeake Bay Watershed Agreement*.

Initial changes will focus on two primary levels of the CBP: Program Leadership and Program Implementation. By July 1, 2026, the PSC will finalize the membership, leadership, responsibilities and decision-making protocols associated with these two structural components. The Management Board will be eliminated.

Key Interim Dates:

April 7th, the PSC meeting to review the draft reorganizational structure.

June 30th, the PSC meeting for final decision.

Members are invited to consider how proposed changes impact CBP decision-making, streamlining, transparency, and accountability. The Stakeholders' Committee's new short-term Accountability Workgroup is a logical forum for interested members to further discuss feedback. Marty Qually, LGAC Chair and Adams County Commissioner (PA), is serving as the Advisory Committee liaison to the signatory team working on governance and structure.

*Background and Context:*

The Indigenous Conservation Council (ICC) signed and submitted a resolution to the Chesapeake Bay Program in January 2025 (modified in July 2025), requesting the following:

- Include the Indigenous Conservation Council as a signatory to the revised *Chesapeake Bay Watershed Agreement* to support Tribal Nations in their right to exercise their treaty rights and serve as full partners in its protection and restoration.
- Establish and fund an Indigenous Guardianship Program as a priority within the *Agreement's* revised goals and strategies that would direct funding to the ICC as a new jurisdictional Signatory partner to be sub-granted to Tribal Nation members to build their tribal capacity.
- Expand the Scientific and Technical Advisory Committee (STAC) with an additional standing seat committed to sharing and honoring Indigenous science within the partnership and building the engagement of Indigenous scientists to enhance the effectiveness of the partnership and respect for Indigenous science.

By July 1, 2026, the PSC is charged with working with the federally recognized tribal nations to develop recommendations on how best to include tribes across the watershed in the Chesapeake Bay Program partnership.
