Agriculture

- At the August meeting, members present on the call achieved consensus on the Agroforestry EPEG recommendations. However, we are still awaiting a vote from one member and are following up with them offline.
- Also included in this meeting was an overview of a long term actions and decisions document that was compiled, a discussion on crediting new and revisiting existing BMPs, a follow-up to the July discussion on monitoring, and a presentation from Tom on Agriculture land use loading rate ratios for managed pasture and managed hay classes. The loading rate ratio discussion will continue at the September AMT meeting.
- Next Meeting: Thurs, September 18th

Forestry

- At the <u>August 6th meeting</u>, the Forestry Workgroup voted to approve the EPEG recommendations to credit silvopasture and alley cropping practices for their water quality benefits in Phase 7 of the watershed model. (The first WQGIT 8/25 agenda item we'll be voting to finalize these same recommendations).
- The Forestry Workgroup also discussed options for the new forest conservation sub-target under the new Healthy Forests and Trees Outcome and convened a small group with the state leads on Thursday, August 21st to iron out proposed recommendations in advance of the upcoming MB meeting in early September. During the next meeting, they will review and discuss the received public feedback in advance of the MB meeting in early September.
- The Forestry Workgroup was invited to join the next Protected Lands Workgroup meeting on Sept 2nd to help refine the protected lands sub-target for forests.
- Staffer for the Forestry and Federal Facilities Workgroups, Marilyn Yang, will be leaving the first week of September to start her masters in Spain. This position is anticipated to be filled mid-late September.

Urban Stormwater

- The USWG canceled their August meeting.
- The UNM Panel met again to review a draft of the expert panel report. They plan to review a revised version in a panel meeting on Sept 11th after which it will be distributed to WTWG, USWG, and WQGIT. It will be presented to the USWG at the Sept 16 meeting.
- Next Meeting: Tues, September 16th and likely UNM on agenda for Sep 18th WQGIT office hours

Wastewater Treatment

- Following the July WWTWG meeting, members finalized decisions on multiple Phase 7 issues. The Sanitary Sewer Area map update was approved, the septic/sewer model methods were approved after further draft results counts were shared with members, and it was agreed to not pursue SSO Loads in Phase 7. Boat Pumpout decision rationale written up and being reviewed by the workgroup.
- The sanitary sewer exfiltration method also reached consensus offline as of 8/22.
- Next Meetings: CSO small group meeting Aug 28th (main WG meeting canceled), WQGIT Office Hours Sep 15th at 1pm on wastewater topics, WWTWG Sep 25th

Watershed Technical

- At the August WTWG meeting, the group voted to approve the agroforestry EPEG Technical appendix, a proposed change to the methodology for buffer upland credit in Phase 7, and two decisional items related to construction acres for Phase 7. The group also heard about a proposed method to handle cover crop excess for Phase 7 and decided to vote on the method. However, following the meeting, a member voted 1-stop, and the cover crop methodology will be revisited at the September meeting.
- FOR REFERENCE (Construction Decision)
 - Mapping Construction: All patches of barren land uses (except "bare shore" and "extractive barren") that became at least 20% developed within 3-5 years represent "Regulated Construction". Scaled NLCD annual change in development will be used to map historic construction and the CBLCM will be used to estimate future construction.
 - Reconciling Mapped and Reported Construction: Construction acres reported at the county scale will be allocated to LRSEGs by the relative amount of a county's mapped construction and new development within each LRSEG.
 - If reported construction exceeds mapped construction in an LRSEG, remaining reported construction acres will be subtracted from the developed sector (proportionally by developed class).
 - If reported construction is less than mapped construction, remaining mapped construction will be reclassed as "compacted pervious" (loading like "mixed open" in Phase 6).

Toxic Contaminants

- The August and September TCW meetings were canceled. TCW leadership will be reaching out to members to discuss priorities and capacity moving forward.

Federal Facilities

- At the <u>August 12th FFWG meeting</u>, the Federal Facilities Workgroup voted to approve the updated federal facilities data layer for the Phase 7 Watershed Model.
- The group also agreed to close discussions around whether federal agencies should be assigned additional land uses/BMPs types in Phase 7 (construction, septic, harvested forest, and agriculture) which are currently not credited to federal agencies in Phase 6. However, further discussion on new rules in CAST around how to track BMP information from the federal agencies will be discussed further at future meetings.
- Note: Caroline will now be staffer for this group moving forward, once Marilyn leaves in September

Milestones

- A draft EPA Expectations for Near-Term Milestones document was shared and Near-Term Milestone Schedule was shared with workgroup members for review. Both will be discussed at the August 29th meeting.

Land Use

- Following the June LUWG meeting and an optional back-cast office hours, the LUWG voted via email and approved the back-cast methods.
- The final land use aggregation will be voted on at the September LUWG meeting, and it is anticipated that the group will also see a draft version of the land use time series data from 1985-2022 and discuss the review process for this data.
