Wastewater	Multiple decision points at July 24 meeting, including sanitary sewer exfiltration methods, and consensus to not pursue SSO loads for Phase 7, though kept opening for MTM areas.

Forestry	At July meeting, began discussion on drafting numeric targets under new outcome, and briefed on Agroforestry EPEG. Will be asked to approve EPEG report at their August 6 meeting. FWG nominated and approved co-Chair nomination, Nancy Sonti, USFS.

Agriculture

- At the July meeting, the group voted to formally adopt the final version of their planning document.
- Given that one of the priority areas that came out of the planning document discussions was water quality monitoring, the group heard from a variety of speakers focused on Chesapeake Bay Program monitoring. Presentations included an introduction to Chesapeake Bay Program water quality monitoring, an overview of how monitoring data informs CAST, a presentation on the Total Maximum Daily Load (TMDL) indicator and Monitored and Expected Total Reduction Indicator for the Chesapeake (METRIC) tool, and updates about a study designed to monitor water-quality conditions in small agricultural watersheds. The group will continue to explore priority topics and items outlined in the approved planning document at future meetings.

Forestry

- During the July 8th meeting, the Forestry Workgroup began discussions on drafting numeric targets for the new forest conservation sub-target under the new Healthy Forests and Trees Outcome. This topic will be discussed more in depth at the next meeting on August 6th, awaiting more guidance following the end of the public comment period on September 1st. The Workgroup also received a briefing on the draft recommendations from the Agroforestry Expert Panel Evaluation Group (EPEG). The Workgroup will be asked to approve the final recommendations at the August 6th meeting.
- FWG has nominated and approved its new Community Co-chair position - Nancy Sonti, USFS

Urban Stormwater

- The USWG met in July and heard an overview of the proposed Phase 7 timeline extension and key decisions that will be needed by the USWG, including approval of the Urban Nutrient Management (UNM) expert panel report and a review of MS4 areas. The workgroup heard an update on the MS4 areas and provided additional data and contacts to update this input layer for the Phase 7 model.
- The UNM Panel also met in July to discuss the literature review of new research since the 2013 Expert Panel. The panel will begin drafting the expert panel report and meet again to have something to share with the workgroup in the September USWG meeting.
- August meeting canceled, next meeting Tuesday September 16th from 10-12.

Wastewater Treatment

- At the June WWTWG meeting, Joseph shared another update on the SSE method focused on how to best account for attenuation. The SSO Small Group shared a summary of SSO data available from jurisdictions and preliminary analysis of SSO loads for sample areas, tentatively proposing to not pursue SSO loads given the limited data available from jurisdictions and the small percentage of urban load from the data received so far.
- At the July WWTWG meeting, WWTWG reached consensus on approving the SSE estimation method and decided not to pursue SSO loads in Phase 7, though allowed for exploration of inclusion in multiple tributary models for some areas. The vote will be finalized by email to account for members not present. The workgroup also heard an update on the septic/sewer model and sanitary sewer areas, which will be finalized in a vote by email after some additional backcast data is shared with members.

Watershed Technical

- The July WTWG meeting was canceled.
- The August WTWG meeting will include a variety of decisional and discussional items including approval of the Agroforestry EPEG technical appendix, decisional items related to the methodology for construction acres in Phase 7, approval of the proposed method for buffer upland credit in Phase 7, a way to handle cover crop excess in Phase 7, and a review of the draft 2025 NEIEN Appendix.
