III. Land Use Aggregation to Phase 7 Land Use Overview

Sarah will share an overview of the aggregation of the 2021/22 high resolution LULC data from its native 56 classes to ~16 classes as input to CAST. These 16 classes are an intermediate land use product between the LULC and CAST land use. The aggregated LULC schema is summarized as acres by LRSEG and delivered to CAST to assess water quality. The vote on the final aggregation will take place at the September LUWG meeting.

IV. Phase 7 CAST Load Sources Overview

Jess will share an overview of the Phase 7 CAST load sources and be available to answer questions. The CAST land use is a combination of the intermediate Phase 7 aggregation with the Census of Agriculture, annually reported forest harvest and construction acres from the states, and CSOs. This produces a table of acres per load source (or land use) by land-river segment in which BMPs are applied and loads are calculated. These will be presented to the WQGIT at the August 25th meeting, so this is a chance for additional background and briefing ahead of that.
