**II. Sanitary Sewer Exfiltration Method**  
Joseph Delesantro, EPA ORISE/CBPO  
Joseph will share an overview of the method for estimating the baseline exfiltration and edge of stream delivery of nitrogen and phosphorus from sanitary sewers in the Phase 7 model. This is new for Phase 7 to better appropriate where these loads are coming from as they are currently

misappropriated mostly to stormwater and lawn fertilizers. The method was approved by the WWTWG at their [July 2025 meeting](#).
