Agriculture

- The AgWG canceled their November meeting. The December meeting was rescheduled back to it's initial date and time (December 18th), given that the Bay in the Balance Conference was rescheduled to March.
- The December 18th meeting will feature program updates, a presentation on the preliminary mapping to BMPs and load source groups, an update on the methodology for the allocation of feed space acres for Phase 7, a discussion on priority BMPs for efficiency evaluation and remote sensing, and takeaways from the Chesapeake Ag Networking Forum.

Wastewater Treatment
