Agriculture

- The AgWG met on September 18th and heard an update from the Agricultural Advisory Committee, discussed a crosswalk resource of NRCS and CAST BMPs, and heard about efforts to remotely sense cover crops in the Chesapeake Bay.
- Next Meeting: October 16th from 10-12
- The AgWG canceled their November meeting and they rescheduled their December meeting, so that the group can meet in person immediately following the Bay in the Balance Conference.

Forestry

- The <u>Riparian Forest Buffer</u> and <u>Tree Canopy</u> <u>indicators</u> have been updated on Chesapeake Progress. See the <u>CBP Press release</u> on the indicator updates for a summary.
- New county and municipal-scale tree canopy status and change fact sheets are now available.
- The <u>State of Chesapeake Forests Storymap</u> has been updated with the latest high-res land use/land cover data.
- Next Meeting: October 8th from 9-11

Urban Stormwater

- USWG met on September 16 and heard updates on the Urban Nutrient Management Expert Panel, MS4 data layer for Phase 7, and the Vulnerability Assessment Guidance tool. Members were not ready to approve the MS4 data layer, and will vote by email on an updated data layer incorporating feedback.
- The decision process for approving the UNM Panel recommendations has been extended to November 2025.
- Next Meeting: Tuesday October 21 from 10-12

Wastewater Treatment

- The regular WWTWG August meeting was canceled. The CSO Small Group met to wrap up discussions with the modeling team on validating data for the phase 7 model and to give feedback on the CSS Data Layer, which will be presented to the workgroup for approval at the Sept meeting.
- Workgroup members approved the Boat Pump-Out Tabling Rationale Summary via email.
- Briefings on main wastewater Phase 7 inputs were presented at the <u>WQGIT Office Hours on Sep 15</u>.
- Next Meeting: Thursday, September 25 from 10-12

Watershed Technical

- Met on September 4th and heard presentations on UNM Expert Panel updates, Phase 7 CAST land uses, and an informational overview of BMP excess. The group voted to approve the 2025 NEIEN Appendix for use in 2025 annual progress submissions.
- Note: At the previous WQGIT, we noted a voting member had voted a 1-stop on the <u>proposed</u> <u>methodology for handling cover crop excess</u>, and consensus was not reached at the August meeting. However, after additional discussions, this voting member updated their vote to a 4, and the methodology passed by consensus.
- Next Meeting: October 2nd from 10-12. The agenda is posted to the <u>calendar page</u>.

Toxic Contaminants

- TCW held office hours in September with workgroup members to start initial discussions about current priorities and future directions for the workgroup. This discussion will continue more deeply after the revised Watershed Agreement is finalized.
- Next Meeting: Joint meeting with Local Leadership Workgroup on Tuesday, October 21 at 9-11am.
- The regularly scheduled meeting on Oct 8 is canceled.

Federal Facilities

Milestones

- The workgroup met Aug 29 to review and give feedback on the EPA Expectations for Near-Term Milestones as well as approve the Near-Term Milestones Schedule for recommendation to the WOGIT.
- Next Meeting: TBD

Land Use

- The LUWG met on September 17th. At this meeting, the group heard an update on the LUDS outcome and discussed potential next steps for the LUWG. The group approved an update to the June 2025 bare shore decisional item, which now states that all bare shore (tidal and non-tidal) that is not classified as construction will be moved to the Phase 7 water class. The LUWG also approved the aggregation of the High resolution LULC data to the 16 phase 7 mapped classes (pending one outstanding vote). The group walked through a web app viewer, put together by USGS, to show draft time series data from 1985-2022. The LUWG will continue their review of this data.
- The LUWG is tentatively working towards a joint meeting with those under the proposed Healthy Lands Goal in December. Additional details will follow.
