- 10:10 Sanitary Sewer Exfiltration Joseph Delesantro, EPA ORISE/CBPO (30 min)
 Joseph will present the sanitary sewer exfiltration estimation method for the Phase 7 model.

Decision Requested: WWTWG voting members will be asked to approve the proposed method for estimate the baseline exfiltration and edge of stream delivery of nitrogen and phosphorus from sanitary sewers in the Phase 7 model.

10:40 Septic/Sewer Model and Sanitary Sewer Area Map Update – Jackie Pickford, USGS (30 min)

Jackie will present updates on the new estimation techniques for septic system counts,
population on septic, and population on sewer, including a comparison of Phase 6 and Phase 7
results at a county scale. This was last presented to the WWTWG at the Nov 2024 joint meeting
