### Issues for Discussion and Resolution

- a. **Vision** How far reaching? Should the Agreement "vision" reflect more than just the ecological value of the bay? Should it also reflect the cultural, historic and recreational value of the entire watershed?
- b. Level of Support for Management Strategies Wording was moved from the goals/outcomes related to jurisdictions having discretion to choose level of support for management strategies. Is it correctly worded for all jurisdictions? Language negotiated by PSC signatory representatives is still intact, with the exception of the addition, "Except for those outcomes required by law and related to the implementation of the TMDLS under the waters quality goal..." Are any changes needed? Public comments were heavy on the side of not giving discretion to the signatories.

#### c. Goals and Outcomes

- The 1987 Agreement included goals, objectives and commitments. Should this agreement use a similar structure to differentiate outcomes (targeted results) from commitments (products or activities/actions)?
- The Partners agreed that management strategies would be developed for all outcomes; however, the current draft includes 30 outcomes. Do the Partners still agree with this or or is there a way to minimize the number of strategies? If only some outcomes have management strategies, how will we explain it to the public?
- An alternative option would be to develop management strategies for each goal (rather than outcome), will the jurisdictions who want to focus on only some of the outcomes have an issue?
