Local Stakeholder Engagement

Local Stakeholder Engagement Web-based meetings

- CWIP Steering Committee members from the relevant jurisdictions are invited to participate in the online workshops and provide introductions.

- Where possible, CIT will secure time on the agenda of a meeting of relevant stakeholders to reduce redundancies.
- CIT members will use a consistent format & slide deck.

Format:


- History of and need for a CWIP, and the meeting objectives.
- Technical overview regarding the BMP identification and selection process along with the implementation opportunity maps that resulted from this process.
- Breakout sessions and get feedback on initial concerns, potential for proposed BMPs, areas that are missing, constraints, and ongoing activities, which will be used to inform revisions to the draft CWIP.
- The CIT will compile feedback from all the online workshops and provide it to the CWIP Steering Committee through the Center for Watershed Protection.

Local Stakeholder Engagement Pennsylvania update

- 8 web-based meetings, one for each of the on PA's Phase 3 WIP Tier 1 & 2 counties
 - Adams, Bedford, Centre, Cumberland, Franklin, Lancaster, Lebanon, York
- Initial notification email sent by PA DEP and by CIT on October 15,
 2020 to a list of 90+ stakeholders approved by DEP
 - County Commissions, Conservation Districts, County Planners,
 County Action Plan Coordinators, state & federal agency staff
- County Action Plan coordinators have offered to help convene management teams & local leaders for workshops
- Scheduling is underway and will be finalized in the next two weeks.




Local Stakeholder Engagement New York update

- Stakeholders in all counties within Primary CWIP Geography will be invited to participate in public comment meetings
 - Broome, Chenango*, Cortland, Delaware*, Madison*, Otsego*, Tioga, Tompkins*)
- 1-3 in-person meetings will be hosted with most-impacted counties:
 - Broome, Cortland, Tioga
- CIT will work with local leaders to enact COVID precautions. Initial notification email sent by CIT on October 16, 2020 to 15 stakeholders approved by DEC
 - Conservation Districts, NYSDEC regional staff, Upper Susquehanna Coalition
- CIT will work with conservation districts to coordinate meetings




Local Stakeholder Engagement Maryland update

- On October 15 we sent initial CWIP information via Constant Contact to 37 individuals.
 - Follow-up reminder sent 4 days later
 - Current "open" rate for Constant Contact messages is at 83.3% with 30% of them clicking on links.
- Continuing to add names to the list.
- Targeting dates for stakeholder workshops in November and December.
- Determining which online platform will work best for all stakeholders
