






Highlights in Delaware

- Completion of Children in Nature/No Child Left Inside Initiative Taskforce Report
- Support of First Lady Carla Markell as Chair of Children in Nature Ambassadors group.
- DNREC provides penalty funds to support implementation.
- Recent cooperative work between Department of Education and environmental education community
- Green Ribbon Schools Program was launched this November 2012.
- DE Dept of Education focuses on 4 major points:
 - more outdoor field trips while providing teachers professional development
 - focus on Green Ribbon Schools
 - invite more informal educators to monthly meetings,
 - aligning Next Generation Science Standards with informal and formal educators
