December Full GIT Meeting

- ExComm agreed the December meeting was helpful and the list of agenda topics was appropriate
- Other than a few technological setbacks (webinar not working and call-in system not loud enough) the meeting ran smoothly and a lot was accomplished
- 2011 Priorities: (ExComm agreed this is an appropriate list to begin work)
 - 1) Blue Catfish Policy
 - 2) Oyster Metrics
 - 3) Blue Crab Abundance Targets
 - 4) Land Use Decision Making Communication Pathways

Clarification

Oyster Metric Team Update (*Stephanie will be calling in at ~1:30pm*)

- The Oyster Metric Team has had two meetings since the December full GIT meeting
 - Consisted of state and federal agencies as well as academic advisors
 - Have made a lot of progress and agreement on metrics
- Stephanie Westby, on behalf of the Oyster Metric Team, wanted to get clarification as to whether their charge included not only how to measure metrics, but also establishing goals
 - ExComm agreed that this what was written in their team paper and they are in charge of creating goals as well
 - The goals do not need to be similar for all sites
 - a. use ranges and scales to develop metrics
 - The goal is to give managers the ability to say they have achieved a certain level of ecological restoration success
- Nancy Butowski added that MDDNR will need a completed product by February in order to review

Decisional

Blue Catfish Workgroup

- Tasks this workgroup should address
 - Synthesis of science across the Bay beyond what we heard at the December meeting
 - Abbreviated stock assessment
 - List of possible recommendations for the GIT to consider
 - Set of possible control strategies/options
 - Develop factsheet explaining the issue and next steps
 - Define management scenarios ranging from complete eradication to no action

- MDDNR will need a completed report by September in order to implement results for 2012
- There is a need to maintain an open and transparent process with stakeholder involvement in order to create a broader understanding
- STAC could fund a workshop, but would need to look into the speed at which this could be accomplished
 - Greg Garmin, a STAC member, also on this blue catfish team, may be able to get the ball rolling on this workshop
- Stakeholder Field Trip:
 - March/April timeframe
 - Get in contact with David Whitehurst about electrofishing

1.) 2011 Blue Crab Plan

- The assessment itself is mostly completed
 - Expect to be finalized/reviewed by the ExComm by end of January
- Adoption of this timeline creates a venue for a broader range of constituents for stakeholder involvement
- June full GIT meeting will be used to disseminate this information

- Bay Barometer Changes and Reporting
 - Abundance targets and thresholds will replace the Fisheries Management Effort Indices

 - 1) Oysters (possibly tributary specific) → Stephanie Westby
 - 2) Juvenile Reproduction Indices → ?
 - 3) Young-of-Year Striped Bass → Eric Durrell
 - Why only one species when we have information on ~25?
 - a. Look into the VIMS Trawl Survey (Mary Fabrizio)
- Executive Order Outcome Progress Reports
 - On track with Blue Crab
 - Oyster Metric Team is just getting started
 - Should give better indication on how to track progress
