Biennial Strategy Review System



Two requested actions:

Science Panel

Main Message: Broaden the application, incentives, partnerships, and impacts of BMP implementation.

NOTABLE POINTS

Lurking Issues: Consider BMPs as systems.

Climate Change: Need to both adapt and mitigate.

Agriculture: Insufficient financial incentives. Pursue "community conservation" – collaborative stewardship, pay-for-performance, auctions, etc.

Social Science: Increase engagement by better understanding attitudes, motivations and resulting behaviors.



Fiscal and Finance Panel

Main Message: Better recognize and apply the strengths of both the public and private sectors.

NOTABLE POINTS

Public and Private Financing: Both sectors have their strengths and weaknesses. The greatest opportunity exists in our ability to engage the power of the private sector.

- Public sector funding alone will not restore Chesapeake Bay.
- Many BMPs work better financed as loans (private) vs grants (public).
- Need to develop means to hold onto funding until most cost effective to apply it vs current "use it or lose it".
- Need to develop means to pool our resources, prioritize Outcomes, and apply where most effective.
- Public sector needs to support private sector investment by reducing risk and increasing certainty.



Policy Panel

Main Message: Better connect with and engage our public.

NOTABLE POINTS

Shared Leadership – we need to call upon the strength of the partnership for shared federal, state, and local leadership.

Broaden Partnerships – we need to reach out to new partners and solidify inter-connectedness.

Improved Marketing – connect our work to messages and actions people truly care about:

- healthy outdoor spaces
- healthy fish and wildlife populations

and their impacts to a healthy economy and robust society.



Cross-Cutting Recommendations

Main Message: "We don't have a pollution problem – we have a stewardship problem."

NOTABLE POINTS

- Social science should be a renewed focus across all Outcomes know the audience, encourage collaboration, communicate to new audiences in terms that are relevant to them (economy, jobs, energy, health, safety, recreation).
- Don't underestimate "lurking" issues in science. Continue to invest in research and monitoring.
- Be open to changes in programs and be flexible in implementation.
- We need to adjust to the fact that behavior change takes more time than expected.
