Given the development of ChesapeakeDecisions and the desire to fully incorporate the lessons identified and feedback received at the Biennial Meeting next week, GIT 6 has recommended pushing the targeted start of the second round of the Strategy Review System back by at least one quarter. This would mean that we would plan to begin the first cohort at the August 2019 Management Board meeting at the earliest, instead of the May 2019 Management Board meeting.

I request that Management Board members raise any major concerns with this change, or agreement with the shift, via email reply. Please respond by March 15, 2019. If we don't hear from you by that date, we may assume that you consent to the change. The final schedule will be informed by discussions at the biennial review meeting in Richmond, and we plan to have a decision item to determine the final 2019-2021 SRS schedule on the April Management Board agenda.
