III. Poster Session: Sufficiency Review (11:00 a.m. – 12:30 p.m.)

Posters stations for each management strategy will be set up around the perimeter of the meeting room. Each poster will identify key elements: “factors Influencing”, “gaps” and “management approaches.” A GIT representative will be posted at each station to pose and answer questions and receive feedback. MB members will rotate in groups to each station and will be asked to *provide feedback based on their pre-meeting reviews of the strategies.*

Note: Focus on big picture; do not wordsmith. The ultimate goal is to improve each strategy in time for public release. Identify yourself on dots and post-it notes.

Questions for reviewers:

- Sufficiency: Is this strategy on the right track? Does it sound reasonable and will it move the Partnership toward achieving the outcome? (use green, yellow, red sticky dots to vote)
- What do you like about the draft? What are the most important features?
- Suggestions for improvements to *management approaches*: What’s missing? How can we fill gaps? What needs to be added? (use post-it notes to suggest changes)
- What’s problematic? Are there management approaches or other elements that your signatories can’t live with? Identify the specific issue and suggest alternative approaches.

Participants should consider the connections between multiple outcomes and the expertise of other GITs/workgroups. Participants should also brainstorm approaches that could result in multiple benefits.
