- May be confusing to navigate
- Information overload
- Contains mix of success and error records

Recommendations

- Improve content and organization
- Provide new information on expired credit

Next Steps

Recommendations

- Add a READ ME tab
- Add an ERROR SUMMARY tab
- Remove validated records from report
- Remove fields that do not provide useful information
- Add information on expired credit

Recommendations: Credit Duration Reports

- Question: How much credit am I losing due to expired credit duration?
- New credit duration reports
 - Summary of uncredited BMPs
 - Detailed submitted vs. credited with BMPs that would have expired because of credit duration
- Credit duration considerations
 - As Other BMPs are credited, then there may not be acres available for some BMPs, resulting in a loss of overall reductions
 - Examples: Land use change BMPs and Urban Stormwater BMPs
