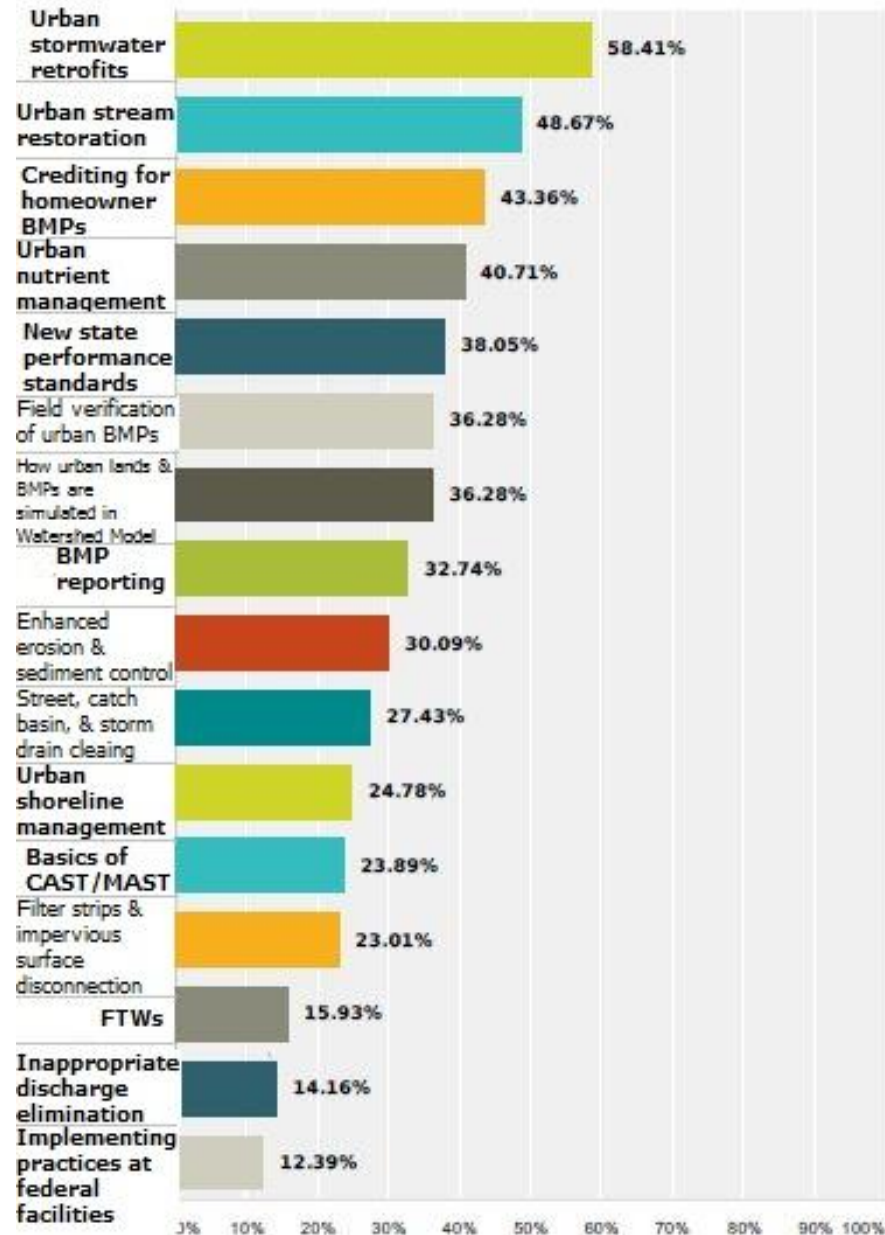


Outreach Effort on CBP Approved Urban BMPs

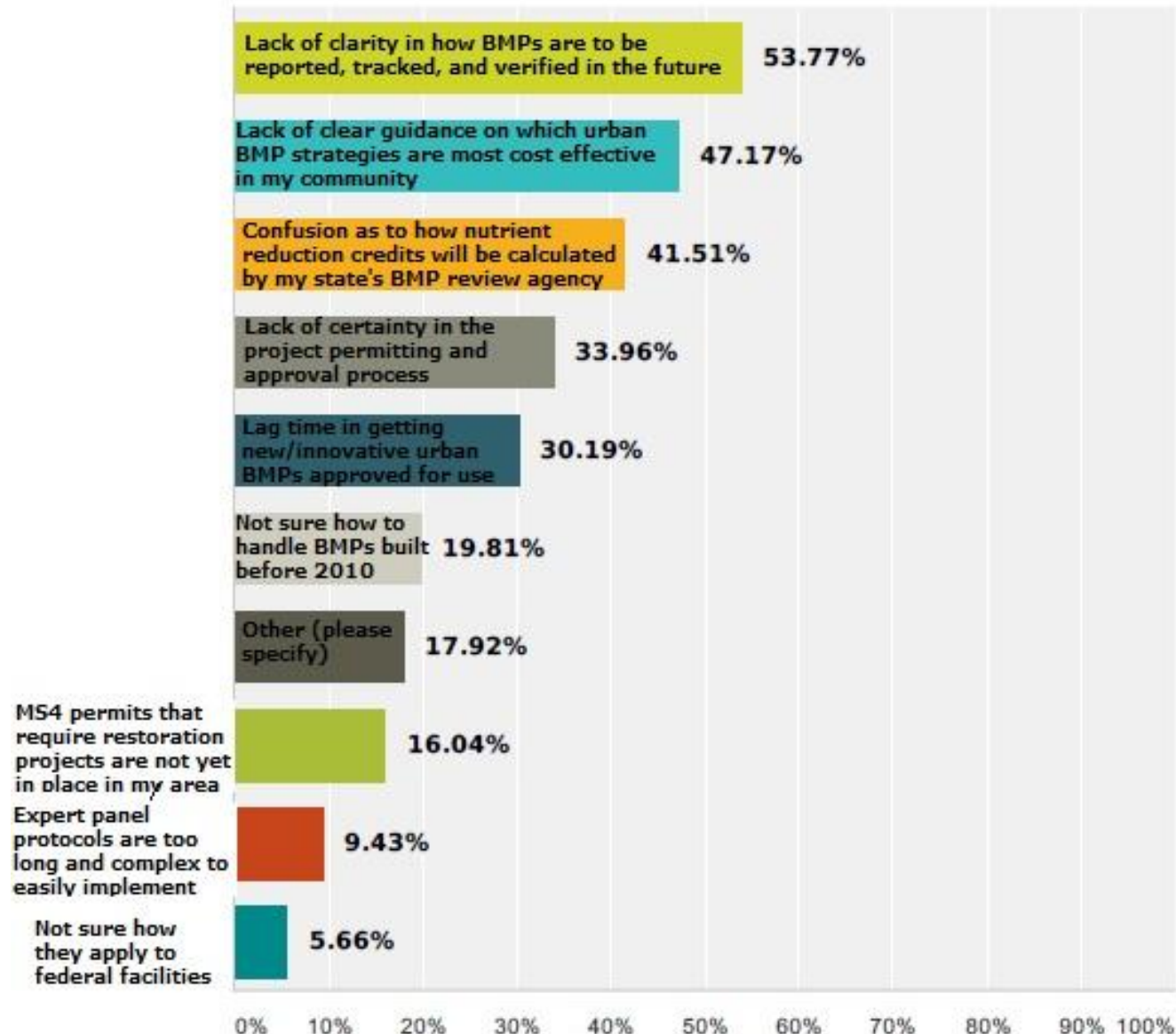
**Q23 Which of the completed or pending

Urban BMP Outreach

- Expert Panel Reports Are Poor Outreach Tool
- Cited as a top priority by stormwater community in 2014 CSN Needs Survey
- Three key outreach modes:
 - Webcasts (12 so far) and Some Workshops
 - E-mail alerts
 - **BMP Fact Sheets**
- Need for state-specific adaptation

Process to Finalize Fact Sheets

- First Draft Completed by CWP by 10/20
- CSN to Review/Revise by 12/1 and distribute to each state stormwater agency
- Each State to provide their own specific information where needed by 12/31
- Distribution thru states/CSN and other outlets during 2015
- Addl BMPs added as they are approved

- Should take no more than 2 hours to update the fact sheets
