## **Proposed Changes to NEIEN to Accommodate Phase 6 Reporting**

## Draft Proposed at 04022015 WTWG

**Objective:** Make changes to NEIEN schema, codes list and appendix such that jurisdictions will NOT need to submit two sets of data in 2015 – one for 2015 Progress and one for Phase 6 calibration. Jurisdictions should only need to manage one set of data for NEIEN, and it will be up to the CBPO to use the same records for multiple purposes.

**Federal Agency Codes:** BMPs will be tracked by federal agency in the Phase 6 Model. This will require the reporting of land-owning agencies for each BMP record. The following changes will be made to NEIEN to accommodate this need:

- Jurisdictions will use the Agencyldentity code already found within the NPSBMPIdentity/DataSource/ContactEntity portion of the NEIEN Schema to submit the landowning federal agency for each record.
- An initial domain of 20-60 federal agency codes will be added to the Codes List (awaiting Federal Facility Team decision). A subset of these (perhaps 8-12) will represent land uses in the Phase 6 Model, while the majority will be represented as "Other Federal Land" in the Model.
- Jurisdictions will also need to identify if the BMP was submitted on non-federal land using an agency code of "Nonfed."
- Jurisdictions may request more agency codes be added to the Agencyldentity code list and mapped either to "Other Federal Land" or non-federal land in the Model.
- Any BMP records with a missing or "NULL" value for Agencyldentity will not receive credit for 2015 Progress or the recalibration.

**Inspection Implementation Qualifier Codes:** The schema was already extended to allow jurisdictions to report inspection dates. However, multiple WTWG members suggested a further extension of the schema to enable states to report if the BMP record passed or failed inspection. The following changes will be made to NEIEN to accommodate this need:

- Jurisdictions will be able to report new elements of "PASS" and "FAIL" under a new schema extension of "EventStatusResultCode." Details on the inspection may also be tracked using explanatory text under a new schema extension of "EventStatusResultsText."
- All records that contain the ImplementationQualifierCode of "INSP" will also now need to be reported as "PASS" or "FAIL."
- Records may fail one inspection, and pass a subsequent inspection or have a subsequent maintenance action completed. In both scenarios the BMP record will lose credit following the failed inspection, but would regain credit in the Phase 6 Model with the follow-up action.

**Land Uses:** CBPO will provide a list of recommended land uses/ land use groups to be used by the NEIEN Appendix. Any existing land uses already submitted to NEIEN will be remapped to new Phase 6 land uses for recalibration needs, but retained for 2015 Progress needs.
