# VI. Riparian Forest Buffer Update

11:40 am - 11:50 am

Forest buffer restoration over the past 5 years has slowed considerably – the exact opposite of what is needed to meet the Forest Buffer Outcome, or to come close to the targets represented in the Phase II WIPs. This is a critical time for riparian forest buffers since USDA is engaged at an unprecedented level as leading the Riparian Forest Buffer Initiative (kicked off by the Riparian Forest Buffer Leadership Summit in DC in June 2014). It is important that the states are engaged at a high level and fully-coordinated across their agencies to address state-specific issues, and respond to common funding and policy issues that have arisen across the watershed.
