## **Selection of WQGIT and Workgroup Voting Members**

Per the WQGIT Governance Protocols, voting members are defined as the signatory representatives of the Chesapeake Bay Watershed Agreement. For the Bay jurisdictions, a specific voting member is defined by the lead agency responsible for developing and implementing the WIPs and is a current, standing member of the WQGIT or a WQGIT Workgroup.

**<u>Action</u>**: Each lead agency/organization listed below will identify one representative and one alternate to serve as voting members on the WQGIT.
