- > Evaluating the Relative Impacts of the Recreational and Commercial Sectors of the Blue Crab Fishery in Maryland (1:00-1:20pm) Matt Ogburn (SERC)
 - o 10-min presentation and 10-min discussion
 - The Fish and Invertebrate Ecology Lab at SERC is conducting two sets of mark-recapture experiments to estimate male and female blue crab exploitation rates by fishery sector. The primary project was funded by Maryland Sea Grant with the objective of determining sex-specific exploitation rates of the recreational fishery in Maryland. A second project focuses on determining the composition of the female spawning stock by nursery habitat origin.
